1 AN ACT  
2 APPROPRIATING MONEYS TO THE STATE BOARD OF EDUCATION AND THE BOARD OF REGENTS  
3 OF THE UNIVERSITY OF IDAHO FOR SPECIAL PROGRAMS FOR FISCAL YEAR 2018;  
4 AND LIMITING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT POSITIONS.

5 Be It Enacted by the Legislature of the State of Idaho:

6 SECTION 1. There is hereby appropriated to the State Board of Education  
7 and the Board of Regents of the University of Idaho for Special Programs, the  
8 following amounts to be expended according to the designated programs and  
9 expense classes, from the listed funds for the period July 1, 2017, through  
10 June 30, 2018:
