AN ACT

1 RELATING TO APPROPRIATIONS OF MONEYS FOR FISCAL YEAR 2019 AND FISCAL YEAR  
2 2020; APPROPRIATING AND TRANSFERRING MONEYS FROM THE CONSUMER PROTEC-  
3 TION FUND TO THE GENERAL FUND FOR FISCAL YEAR 2019; APPROPRIATING AND  
4 TRANSFERRING MONEYS FROM THE OPPORTUNITY SCHOLARSHIP FUND TO THE PUB-  
5 LIC EDUCATION STABILIZATION FUND FOR FISCAL YEAR 2020; APPROPRIATING  
6 AND TRANSFERRING MONEYS FROM THE GENERAL FUND TO THE PUBLIC EDUCATION  
7 STABILIZATION FUND FOR FISCAL YEAR 2020; APPROPRIATING AND TRANSFER-  
8 RING MONEYS FROM THE GENERAL FUND TO THE TECHNOLOGY INFRASTRUCTURE STA-  
9 BILIZATION FUND FOR FISCAL YEAR 2020; APPROPRIATING AND TRANSFERRING  
10 MONEYS FROM THE GENERAL FUND TO THE DISASTER EMERGENCY FUND FOR FISCAL  
11 YEAR 2020; AND DECLARING AN EMERGENCY.

13 Be It Enacted by the Legislature of the State of Idaho:

14 SECTION 1. There is hereby appropriated and the State Controller shall  
15 transfer \$9,000,000 from the Consumer Protection Fund to the General Fund as  
16 soon as practicable for the period July 1, 2018, through June 30, 2019.

17 SECTION 2. There is hereby appropriated and the State Controller shall  
18 transfer \$3,400,000 from the Opportunity Scholarship Fund to the Public Edu-  
19 cation Stabilization Fund on July 1, 2019, or as soon thereafter as practica-  
20 ble for the period July 1, 2019, through June 30, 2020.

21 SECTION 3. There is hereby appropriated and the State Controller shall  
22 transfer \$8,600,000 from the General Fund to the Public Education Stabiliza-  
23 tion Fund on July 1, 2019, or as soon thereafter as practicable for the period  
24 July 1, 2019, through June 30, 2020.

25 SECTION 4. There is hereby appropriated and the State Controller shall  
26 transfer \$8,053,500 from the General Fund to the Technology Infrastructure  
27 Stabilization Fund on July 1, 2019, or as soon thereafter as practicable for  
28 the period July 1, 2019, through June 30, 2020.

29 SECTION 5. There is hereby appropriated and the State Controller shall  
30 transfer \$2,000,000 from the General Fund to the Disaster Emergency Fund on  
31 July 1, 2019, or as soon thereafter as practicable for the period July 1,  
32 2019, through June 30, 2020.

33 SECTION 6. An emergency existing therefor, which emergency is hereby  
34 declared to exist, Section 1 of this act shall be in full force and effect on  
35 and after passage and approval.
