1 APPROPRIATING MONEYS TO THE MILITARY DIVISION FOR FISCAL YEAR 2012; LIMITING  
 2 THE NUMBER OF FULL-TIME EQUIVALENT POSITIONS; AND GRANTING A CONTINUOUS  
 3 APPROPRIATION FOR THE BUREAU OF HOMELAND SECURITY'S MISCELLANEOUS REV-  
 4 ENUE FUND.

6 Be It Enacted by the Legislature of the State of Idaho:

7 SECTION 1. There is hereby appropriated to the Military Division, the  
 8 following amounts to be expended according to the designated programs and  
 9 expense classes, from the listed funds for the period July 1, 2011, through  
 10 June 30, 2012:

15 SECTION 2. FTP AUTHORIZATION. In accordance with Section 67-3519,  
16 Idaho Code, the Military Division is authorized no more than two hundred  
17 thirty-nine and eight-tenths (239.8) full-time equivalent positions at any  
18 point during the period July 1, 2011, through June 30, 2012, unless specifi-  
19 cally authorized by the Governor. The Joint Finance-Appropriations Commit-  
20 tee will be notified promptly of any increased positions so authorized.

21 SECTION 3. CONTINUOUS APPROPRIATION. The Military Division is hereby  
22 granted continuous appropriation authority for the Bureau of Homeland Secu-  
23 rity's Miscellaneous Revenue Fund for the period July 1, 2011, through June  
24 30, 2012, for the purpose of covering incurred costs arising out of hazardous  
25 substance incidents.
