AN ACT

1 APPROPRIATING MONEYS TO THE DEPARTMENT OF ADMINISTRATION FOR FISCAL YEAR
2 2018; LIMITING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT POSI-
3 TIONS; PROVIDING A DEDICATED FUND CASH TRANSFER; DIRECTING THE HEALTH
4 INSURANCE PLAN FOR STATE EMPLOYEES; AND PROVIDING LEGISLATIVE INTENT
5 FOR USE OF FUNDS FOR A SPECIFIC PURPOSE.

7 Be It Enacted by the Legislature of the State of Idaho:

8 SECTION 1. There is hereby appropriated to the Department of Adminis-
9 tration, the following amounts to be expended according to the designated
10 programs and expense classes, from the listed funds for the period July 1,
11 2017, through June 30, 2018:

23 SECTION 2. FTP AUTHORIZATION. In accordance with Section 67-3519,
 24 Idaho Code, the Department of Administration is authorized no more than one
 25 hundred forty (140) full-time equivalent positions at any point during the
 26 period July 1, 2017, through June 30, 2018, unless specifically authorized
 27 by the Governor. The Joint Finance-Appropriations Committee will be noti-
 28 fied promptly of any increased positions so authorized.

29 SECTION 3. CASH TRANSFER. There is hereby appropriated to the Depart-
 30 ment of Administration and the State Controller shall transfer \$1,737,500
 31 from the Permanent Building Fund to the Administrative and Accounting Ser-
 32 vices Fund on July 1, 2017, or as soon thereafter as necessary, for the Public
 33 Officials' Capitol Mall Facilities payment in the Division of Public Works
 34 due in fiscal year 2018.

35 SECTION 4. HEALTH INSURANCE PREMIUM. The Office of Group Insurance
 36 shall maintain the current health insurance program structure and benefit
 37 package for state employees with the exception of the health insurance con-
 38 tinuation premium, which should be reduced from thirty (30) months to six (6)
 39 months for employees on disability status. The office shall maintain the

1 employer and employee cost-sharing split recommended by the Governor and the
2 Legislature's Joint Change in Employee Compensation Committee.

3 SECTION 5. LEGISLATIVE INTENT. It is the intent of the Legislature that
4 funds appropriated for capital outlay for the Purchasing program in Section
5 1 of this act, from the Administration and Accounting Services Fund, shall be
6 used to participate in the auction of the 590 West Washington Street property
7 in Boise, Idaho, only if the Idaho Board of Land Commissioners proceeds with
8 the disposition of the property during fiscal year 2018.
