AN ACT

1 RELATING TO THE DIVISION OF BUILDING SAFETY; AMENDING SECTION 39-4106, IDAHO
2 CODE, TO REVISE PROVISIONS RELATING TO THE IDAHO BUILDING CODE BOARD
3 MEMBER COMPENSATION; AND AMENDING SECTION 54-1908, IDAHO CODE, TO RE-
4 VISE PROVISIONS RELATING TO THE PUBLIC WORKS CONTRACTORS LICENSE BOARD
5 MEMBER COMPENSATION.

7 Be It Enacted by the Legislature of the State of Idaho:

8 SECTION 1. That Section 39-4106, Idaho Code, be, and the same is hereby
9 amended to read as follows:

10 39-4106. IDAHO BUILDING CODE BOARD CREATED -- MEMBERSHIP -- APPOINT-
11 MENT -- TERMS -- QUORUM -- COMPENSATION -- MEETINGS. (1) The Idaho building
12 code board is established within the division as an appeals, code adoption
13 and rulemaking board, to be appointed by the governor, and shall consist of
14 ten (10) members: one (1) member of the general public; one (1) local fire
15 official; one (1) licensed engineer; one (1) licensed architect; two (2) lo-
16 cal building officials, one (1) from a county and one (1) from a city; two (2)
17 building contractors, one (1) residential contractor who is an active mem-
18 ber of the Idaho building contractors association with construction knowl-
19 edge based primarily on a work history of buildings regulated by the Interna-
20 tional Residential Code, and one (1) commercial contractor who is an active
21 member of either the associated builders and contractors or the associated
22 general contractors of America with construction knowledge based primarily
23 on a work history of buildings regulated by the International Building Code;
24 one (1) representative of the modular building industry; and one (1) indi-
25 vidual with a disability from an organization that represents people with
26 all types of disabilities. Board members shall be appointed for terms of
27 four (4) years and until their successor has been appointed. Three (3) con-
28 secutive failures by a member to attend meetings of the board without reason-
29 able cause shall constitute cause for removal of the member from the board by
30 the governor. Whenever a vacancy occurs, the governor shall appoint a quali-
31 fied person to fill the vacancy for the unexpired portion of the term.

32 (2) The members of the board shall, at their first regular meeting fol-
33 lowing the effective date of this chapter and every two (2) years thereafter,
34 elect by majority vote of the members of the board, a chairman who shall pre-
35 side at meetings of the board. A majority of the currently appointed members
36 of the board shall constitute a quorum.

37 (3) Each member of the board not otherwise compensated by public moneys
38 shall be compensated as provided by section 59-509 (~~h~~), Idaho Code, for each
39 day spent in attendance at meetings of the board.

40 (4) The board shall meet for regular business sessions at the call of
41 the administrator, chairman, or at the request of four (4) members of the
42 board, provided that the board shall meet at least biannually.

1 SECTION 2. That Section 54-1908, Idaho Code, be, and the same is hereby
2 amended to read as follows:

3 54-1908. MEETINGS -- QUORUM. The board shall hold not less than four
4 (4) regular meetings each year, on a day not later than the fifteenth day of
5 the month in each of the months of January, April, July and October, for the
6 purpose of transacting such business as may properly come before it. At the
7 April meeting of each year the board shall elect officers. Special or regu-
8 lar monthly meetings of the board may be held at such times as the board may
9 provide in the rules. Four (4) members of the board shall constitute a quo-
10 rum. Two (2) members of the board may call a special meeting at any time. Due
11 notice of each meeting of the board and the time and place thereof shall be
12 given each member in the manner prescribed in the rules. Each member of the
13 board shall be compensated as provided by section 59-509(~~hn~~), Idaho Code,
14 and paid from the public works contractors license board account.
