RELATING TO THE APPROPRIATION TO THE DEPARTMENT OF FINANCE; APPROPRIATING
MONEYS TO THE DEPARTMENT OF FINANCE FOR FISCAL YEAR 2021; LIMITING THE
NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT POSITIONS; PROVIDING FOR THE
CONTINUOUS APPROPRIATION OF DAMAGES AWARDED FROM THE MORTGAGE RECOVERY
FUND; PROVIDING REAPPROPRIATION AUTHORITY; APPROPRIATING ADDITIONAL
MONEYS TO THE DEPARTMENT OF FINANCE FOR FISCAL YEAR 2020; AND DECLARING
AN EMERGENCY.

9 Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. There is hereby appropriated to the Department of Finance the following amounts to be expended according to the designated expense classes from the listed funds for the period July 1, 2020, through June 30, 2021:

SECTION 2. FTP AUTHORIZATION. In accordance with Section 67-3519,
Idaho Code, the Department of Finance is authorized no more than sixty-six
(66.00) full-time equivalent positions at any point during the period July
1, 2020, through June 30, 2021, unless specifically authorized by the Gover nor. The Joint Finance-Appropriations Committee will be notified promptly
of any increased positions so authorized.

SECTION 3. CONTINUOUS APPROPRIATION AUTHORITY. The Department of Finance is hereby granted continuous appropriation authority for reimbursement of persons to whom the Idaho courts have made a final determination of actual damages resulting from acts constituting violations of the Idaho Residential Mortgage Practices Act by a mortgage broker, mortgage lender, or mortgage loan originator who was licensed or required to be licensed pursuant to Chapter 31, Title 26, Idaho Code.

SECTION 4. REAPPROPRIATION AUTHORITY. There is hereby reappropriated 1 2 to the Department of Finance any unexpended and unencumbered balances appropriated or reappropriated to the Department of Finance from the State 3 Regulatory Fund for construction and building expenses for fiscal year 2020, 4 in an amount not to exceed \$1,800,000 from the State Regulatory Fund, to be 5 used for nonrecurring expenditures related to building and construction 6 7 costs for the period July 1, 2020, through June 30, 2021. The State Controller shall confirm the reappropriation amount, by fund, expense class, 8 and program, with the Legislative Services Office prior to processing the 9 reappropriation authorized herein. 10

SECTION 5. In addition to the appropriation made in Section 1, Chapter lo6, Laws of 2019, and any other appropriation provided by law, there is hereby appropriated to the Department of Finance \$1,800,000 from the State Regulatory Fund to be expended for operating expenditures for the period July 1, 2019, through June 30, 2020.

SECTION 6. An emergency existing therefor, which emergency is hereby declared to exist, Section 5 of this act shall be in full force and effect on and after passage and approval.
