AN ACT

1 RELATING TO COSMETICIANS; AMENDING SECTION 54-828, IDAHO CODE, TO REVISE  
2 PROVISIONS RELATING TO THE MEMBERS OF THE IDAHO BOARD OF COSMETOLOGY;  
3 AND AMENDING SECTION 54-829, IDAHO CODE, TO REVISE PROVISIONS RELATING  
4 TO THE QUALIFICATIONS OF MEMBERS OF THE IDAHO BOARD OF COSMETOLOGY.

6 Be It Enacted by the Legislature of the State of Idaho:

7 SECTION 1. That Section 54-828, Idaho Code, be, and the same is hereby  
8 amended to read as follows:

9 54-828. IDAHO BOARD OF COSMETOLOGY -- APPOINTMENT -- TERM. There  
10 is hereby created in the department of self-governing agencies a board  
11 to be known as the "Idaho Board of Cosmetology." It shall consist of  
12 three (3) registered cosmetologists, one (1) ~~from the northern section~~  
13 ~~of the state, one (1) from the south central section of the state, and~~  
14 ~~one (1) from the southeastern section of the state~~ nail technician,  
15 one (1) electrologist/esthetician and ~~one~~ two (12) currently active  
16 cosmetology school representatives, appointed by the governor ~~from among~~  
17 ~~nominees recommended by any organized and generally recognized group of~~  
18 ~~cosmetologists in this state.~~ The members of the board shall be appointed  
19 for terms of three (3) years. On the expiration of the term of any member,  
20 his successor shall be appointed in like manner by the governor for a term of  
21 three (3) years. Vacancies shall be filled in like manner for the unexpired  
22 portion of the term. Members of the board shall hold office until their  
23 successors have been appointed and have qualified. The board may, by written  
24 agreement, authorize the bureau of occupational licenses as agent to act in  
25 its interest.

26 The action and report in writing of a majority of the board with  
27 reference to the violation of any of the provisions of this chapter shall be  
28 the basis for the board to proceed according to the provisions of sections  
29 54-816, 54-817, and 54-821, Idaho Code.

30 SECTION 2. That Section 54-829, Idaho Code, be, and the same is hereby  
31 amended to read as follows:

32 54-829. BOARD -- QUALIFICATIONS OF MEMBERS. (1) Members of the board  
33 shall be at least twenty-five (25) years of age, and residents of this  
34 state for at least five (5) years prior to their appointment, and they  
35 shall have been engaged in the practice of cosmetology for at least three  
36 (3) years immediately preceding their appointment, and shall be licensed  
37 cosmetologists under the provision of this ~~act~~ chapter.

38 (2) ~~No~~ The cosmetologist, nail technician and electrologist/esthetician  
39 members of the board shall not be affiliated with a school of cosmetology or  
40 company selling cosmetic supplies while in office, ~~and~~.

1       (3) Of the two (2) cosmetology school representatives on the board,  
2 at least one (1) shall have a monetary interest in school ownership and  
3 both such members shall be actively involved in the school management and  
4 finances.

5       (4) No two (2) members of the board can be graduates of the same  
6 school of cosmetology ~~except that the qualifications for the cosmetology~~  
7 ~~school representative and the electrologists shall be established by board~~  
8 ~~regulations.~~
