HOUSE BILL NO. 657

AN ACT

1 RELATING TO IMMUNIZATION ASSESSMENTS; AMENDING SECTION 41-6002, IDAHO CODE,
2 AS ADDED BY HOUSE BILL NO. 432, SECOND REGULAR SESSION OF THE SIXTIETH
3 IDAHO LEGISLATURE, TO REVISE A DEFINITION; DECLARING AN EMERGENCY,
4 PROVIDING RETROACTIVE APPLICATION AND PROVIDING A SUNSET DATE.

6 Be It Enacted by the Legislature of the State of Idaho:

7 SECTION 1. That Section 41-6002, Idaho Code, as added by House Bill No.
8 432, Second Regular Session of the Sixtieth Idaho Legislature, be, and the
9 same is hereby amended to read as follows:

10 41-6002. DEFINITIONS. As used in this chapter:

11 (1) "Board" means the Idaho immunization assessment board created by
12 section 41-6003, Idaho Code.

13 (2) "Carrier" means: ~~any entity required subject to be licensed or~~
14 ~~registered in the state of Idaho regulation by the department that provides~~
15 ~~health insurance, health benefit plans, or is authorized to provide health~~
16 ~~insurance or health benefit plans, or that administers health insurance~~
17 ~~or health benefit coverage or that otherwise provides a plan of health~~
18 ~~insurance coverage or benefits to residents of this state as certificate~~
19 ~~holders under a group policy issued or delivered outside of this state.~~
20 For purposes of this chapter, the term "carrier" includes an insurance
21 company, a hospital or professional service corporation, a fraternal
22 benefit society, a managed care organization, entities that provide excess
23 or stop-loss insurance, and persons or entities ~~acting as an administrator~~
24 ~~or third party administrator of health insurance or health benefits as~~
25 ~~defined by or~~ required to be registered with the director under chapter 9,
26 title 41, Idaho Code. For the purposes of this chapter, the term "carrier"
27 does not include an entity that only issues policies, certificates or
28 subscriber contracts within the state of Idaho that are limited to a specific
29 disease, hospital confinement indemnity, accident-only, credit, dental,
30 vision, medicare supplement, long-term care, disability income insurance,
31 student health benefits only coverage issued as a supplement to liability
32 insurance, worker's compensation or similar insurance, automobile medical
33 payment insurance, or nonrenewable short-term coverage issued for a period
34 of twelve (12) months or less.

36 (3) "Director" means the director of the department of insurance of the
37 state of Idaho.

38 (4) "Fund" means the Idaho immunization dedicated vaccine fund created
39 in section 41-6007, Idaho Code.

40 (5) "Idaho immunization program" means that program administered by
41 the Idaho department of health and welfare to provide vaccinations against
42 diseases to Idaho children consistent with Idaho and federal law.

1 (6) "Plan of operation" means the plan of operation of the fund as
2 established by the board.

3 (7) "Program-eligible child" means any child, natural or adopted,
4 who is under nineteen (19) years of age, whose custodial parent or legal
5 guardian resides in Idaho and who is not eligible for the federal vaccines
6 for children program.

7 (8) "Vaccine" means any preparations of killed microorganisms, living
8 attenuated organisms or living fully virulent organisms that are approved
9 by the federal food and drug administration and recommended by the federal
10 advisory committee on immunization practices of the centers for disease
11 control and prevention.

12 (9) "Vaccines for children" program is that federally funded program
13 that provides vaccines at no cost to eligible children pursuant to section
14 1928 of the social security act.

15 SECTION 2. An emergency existing therefor, which emergency is hereby
16 declared to exist, this act shall be in full force and effect on and after its
17 passage and approval, and retroactively to February 1, 2010.

18 SECTION 3. The provisions of Chapter 60, Title 41, Idaho Code, shall be
19 null, void and of no force and effect on and after July 1, 2013.
