Notwithstanding any other provision of law to the contrary, the appropriation made in Section 1, Chapter 313, Laws of 2009, to the Sec-8 retary of State is hereby reduced by the following amount according to the 9 designated expense classes from the listed fund for the period July 1, 2009, 10 through June 30, 2010: 11 FOR: 12 Personnel Costs 13 \$82,300 Operating Expenditures 14 58,500 TOTAL 15 \$140,800 16 FROM: General Fund 17 \$140,800 SECTION 2. There is hereby appropriated to the Secretary of State the 18 following amounts to be expended for the designated programs according to 19 the designated expense classes from the listed funds for the period July 1, 20 2010, through June 30, 2011: 21 22 FOR FOR 23 PERSONNEL OPERATING COSTS EXPENDITURES TOTAL 24 I. SECTION 3. In accordance with Section 67-3519, Idaho Code, the Office of the Secretary of State is authorized no more than thirty (30) full-time equivalent positions at any point during the period July 1, 2010, through June 30, 2011, for the programs specified in Section 2 of this act, unless specifically authorized by the Governor. The Joint Finance-Appropriations Committee will be notified promptly of any increased positions so authorized.
