HOUSE CONCURRENT RESOLUTION NO. 27

BY STATE AFFAIRS COMMITTEE

A CONCURRENT RESOLUTION

PROVIDING FOR PRINTING THE SESSION LAWS, FIXING THE PRICE FOR PRINTING THE
SAME, AND THE PRICE WHICH THE PUBLIC SHALL BE CHARGED FOR COPIES OF THE
SESSION LAWS.

Be It Resolved by the Legislature of the State of Idaho:

WHEREAS, Section 67-904, Idaho Code, has made provisions for the print-
ing of the Session Laws.

NOW, THEREFORE, BE IT RESOLVED by the members of the First Regular Ses-
sion of the Sixty-second Idaho Legislature, the House of Representatives
and the Senate concurring therein, in accordance with a written contract
duly made and entered into by the Speaker of the House of Representatives and
the President Pro Tempore of the Senate and the House Judiciary, Rules, and
Administration Committee and the Senate Judiciary and Rules Committee of
the Legislature of the State of Idaho, hereinafter referred to as the Joint
Printing Committee, that the contract for the printing of the Session Laws of
the First Regular Session and any Extraordinary Sessions of the Sixty-second
Idaho Legislature in accordance with the provisions of law and in accordance
with the written contract between the Speaker of the House of Representa-
tives and the President Pro Tempore of the Senate and the Joint Printing
Committee as party of the first part, and THE CAXTON PRINTERS, LTD., Cald-
well, Idaho, as party of the second part, be, and the same is hereby ratified
and confirmed, and is incorporated herein and made a part of the resolution,
in words and figures following, to wit:

PRINTING CONTRACT

THIS AGREEMENT, made and entered into the 15th day of March, 2013, by
and between the Speaker of the House of Representatives and the President
Pro Tempore of the Senate and the Joint Printing Committee, hereinafter re-
ferred to as party of the first part, and THE CAXTON PRINTERS, LTD., Cald-
well, Idaho, hereinafter referred to as party of the second part:

WITNESSETH:

That pursuant to a resolution of said party of the first part and written
quotation submitted to the said party of the first part by the party of the
second part, a contract for legislative printing is hereby awarded to said
THE CAXTON PRINTERS, LTD., as follows:

SESSION LAWS
FIRST REGULAR SESSION
AND ANY EXTRAORDINARY SESSIONS
SIXTY-SECOND LEGISLATURE

As outlined in the February 8, 2013, quote of the party of the second
part, the Session Laws will be printed and charged at a price per page not
to exceed seventeen dollars and forty-five cents (\$17.45) based on incre-
mental numbers of copies ordered. The number of copies to be supplied under

1 this contract shall be specified at the time of order. The charge for indi-
 2 vidually binding the books shall not exceed eleven dollars and fifty cents
 3 (\$11.50) per volume based on the number of copies ordered. The party of the
 4 second part shall provide additional copies to be made available for sale to
 5 the general public, and based on the number of copies ordered by the party of
 6 the first part, the price to the general public shall not exceed fifty dol-
 7 lars (\$50.00) for single volumes and sixty-three dollars (\$63.00) per set of
 8 two volumes if a second volume is required. The Session Laws of any Extraor-
 9 dinary Session adjourned prior to June 1, 2013, shall be included in the Ses-
 10 sion Laws of the First Regular Session. No charge shall be made by the party
 11 of the second part for proofreading or blank pages.

12 IT IS AGREED between the parties hereto that all of said printing shall
 13 be done in the form and manner as submitted in the quote of the party of the
 14 second part dated February 8, 2013, in compliance with the statutes of the
 15 State of Idaho where not otherwise provided, such statutes shall be control-
 16 ling.

17 IT IS FURTHER AGREED that said Session Laws shall be printed, delivered
 18 and be ready for distribution by the Secretary of State in conformity with
 19 the provisions of Section 67-904, Idaho Code, which section is hereby re-
 20 ferred to and by such reference made a part of this contract as though set
 21 forth herein at length.

22 IN WITNESS WHEREOF, the party of the second part has caused these
 23 presents to be executed by its proper official, and the party of the first
 24 part, by Concurrent Resolution, has caused these presents to be executed by
 25 its proper officials.
