A CONCURRENT RESOLUTION

- 2 STATING FINDINGS OF THE LEGISLATURE AND REJECTING CERTAIN RULES OF THE
  3 INDUSTRIAL COMMISSION RELATING TO BOILER AND PRESSURE VESSEL SAFETY
  4 RULES.
- 5 Be It Resolved by the Legislature of the State of Idaho:

6 WHEREAS, the Legislature is vested with authority to reject executive 7 agency rules under the provisions of Section 67-5291, Idaho Code, in the 8 event that the Legislature finds that the rules are not consistent with 9 legislative intent; and

WHEREAS, it is the finding of the Legislature that certain rules of the Industrial Commission relating to Boiler and Pressure Vessel Safety Rules – General, Boiler and Pressure Vessel Safety Rules – Administration, Boiler and Pressure Vessel Safety Rules – Inspections, Boiler and Pressure Vessel Safety Rules – Repairs and Alterations and Boiler and Pressure Vessel Safety Rules – Boiler Attendants are not consistent with legislative intent and should be rejected.

NOW, THEREFORE, BE IT RESOLVED by the members of the Second Regular 17 Session of the Sixtieth Idaho Legislature, the House of Representatives and 18 19 the Senate concurring therein, that IDAPA 17.06.01, Rules Governing Boiler and Pressure Vessel Safety Rules - General, IDAPA 17.06.02, Rules Governing 20 21 Boiler and Pressure Vessel Safety Rules - Administration, IDAPA 17.06.03, Rules Governing Boiler and Pressure Vessel Safety Rules - Inspections, IDAPA 22 17.06.04, Rules Governing Boiler and Pressure Vessel Safety Rules - Repairs 23 and Alterations and IDAPA 17.06.05, Boiler and Pressure Vessel Safety Rules 24 - Boiler Attendants, Rules of the Industrial Commission, adopted as pending 25 rules under Docket Numbers 17-0601-0901 (Chapter Repeal), 17-0602-0901 26 (Chapter Repeal), 17-0603-0901 (Chapter Repeal), 17-0604-0901 (Chapter 27 Repeal) and 17-0605-0901 (Chapter Repeal), the entire rulemaking dockets, 28 be, and the same are hereby rejected and declared null, void and of no force 29 and effect. 30
