SENATE BILL NO. 1030

AN ACT

1 RELATING TO THE BOARD OF COUNTY COMMISSIONERS; AMENDING SECTION 31-703,
2 IDAHO CODE, TO REVISE PROVISIONS RELATING TO THE TERM OF OFFICE OF A
3 COUNTY COMMISSIONER; AND AMENDING SECTION 34-617, IDAHO CODE, TO PRO-
4 VIDE THAT ON AND AFTER A DATE CERTAIN EACH MEMBER OF A BOARD OF COUNTY
5 COMMISSIONERS SHALL BE ELECTED FROM THE DISTRICT IN WHICH HE RESIDES.

7 Be It Enacted by the Legislature of the State of Idaho:

8 SECTION 1. That Section 31-703, Idaho Code, be, and the same is hereby
9 amended to read as follows:

10 31-703. TERM OF OFFICE. The term of office of a commissioner shall be
11 as follows:

12 At the general election in ~~1936~~ 2014, two (2) members shall be elected
13 for a term of two (2) years and one (1) member for a term of four (4) years; ~~a~~
14 . At each biennial election thereafter, one (1) member shall be elected for
15 a term of two (2) years and one (1) member for a term of four (4) years, ~~it be-~~
16 ~~ing further provided that a.~~ At the general election in ~~1936~~ 2014, the com-
17 missioner from county commissioner's district number one, shall be elected
18 for a term of four (4) years and ~~that~~ the four (4) year term shall be allotted
19 thereafter in rotation to districts number two, three, and one.

20 SECTION 2. That Section 34-617, Idaho Code, be, and the same is hereby
21 amended to read as follows:

22 34-617. ELECTION OF COUNTY COMMISSIONERS -- QUALIFICATIONS. (1) A
23 board of county commissioners shall be elected in each county at the general
24 elections as provided by section 31-703, Idaho Code. On and after the gen-
25 eral election in 2014, each member of a board of county commissioners shall
26 be elected from the district in which he resides.

27 (2) No person shall be elected to the board of county commissioners un-
28 less he has attained the age of twenty-one (21) years at the time of the elec-
29 tion, is a citizen of the United States, and shall have resided in the county
30 one (1) year next preceding his election and in the district which he repre-
31 sents for a period of ninety (90) days next preceding the primary election.

32 (3) Each candidate shall file his declaration of candidacy with the
33 county clerk.

34 (4) Each candidate who files a declaration of candidacy shall at the
35 same time pay a filing fee of forty dollars (\$40.00) which shall be deposited
36 in the county treasury.
