SENATE BILL NO. 1141

AN ACT

1 APPROPRIATING MONEYS TO THE STATE TREASURER FOR FISCAL YEAR 2014; LIM-
2 ITING THE NUMBER OF FULL-TIME EQUIVALENT POSITIONS; PROVIDING STATE
3 TREASURER LGIP FUND REAPPROPRIATION FOR FISCAL YEAR 2014; PROVIDING
4 GUIDANCE FOR EMPLOYEE COMPENSATION; PROVIDING LEGISLATIVE INTENT FOR
5 THE USE OF CONFERENCE RELATED ACTIVITIES; AND PROVIDING LEGISLATIVE
6 INTENT FOR THE PAYMENT OF BANK SERVICE FEES.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. There is hereby appropriated to the State Treasurer, the
10 following amounts to be expended for the designated expense classes, from
11 the listed funds for the period July 1, 2013, through June 30, 2014:

27 SECTION 2. FTP AUTHORIZATION. In accordance with Section 67-3519,
28 Idaho Code, the State Treasurer is authorized no more than twenty-six (26)
29 full-time equivalent positions at any point during the period July 1, 2013,
30 through June 30, 2014, unless specifically authorized by the Governor. The
31 Joint Finance-Appropriations Committee will be notified promptly of any
32 increased positions so authorized.

33 SECTION 3. STATE TREASURER LGIP FUND REAPPROPRIATION AUTHORITY. There
34 is hereby reappropriated to the State Treasurer any unexpended and unencum-
35 bered balances of moneys made from the State Treasurer LGIP Fund for fiscal
36 year 2014, to be used for nonrecurring expenditures, for the period July 1,
37 2013, through June 30, 2014.

1 SECTION 4. EMPLOYEE COMPENSATION. The Legislature finds that investing
2 in state employee compensation should remain a high priority even in tough
3 economic times, and therefore strongly encourages agency directors, insti-
4 tution executives and the Division of Financial Management to approve the
5 use of salary savings to provide either one-time or ongoing merit increases
6 for deserving employees, and also target employees who are below policy com-
7 pensation. Such salary savings could result from turnover and attrition, or
8 be the result of innovation and reorganization efforts that create savings.
9 Such savings should be reinvested in employees. Agencies are cautioned to
10 use one-time funding for one-time payments and ongoing funding for permanent
11 pay increases.

12 SECTION 5. CONFERENCE RELATED ACTIVITIES. It is the intent of the Leg-
13 islature that no more than \$10,000 from the General Fund, as appropriated in
14 Section 1 of this act, shall be spent on various conference related activ-
15 ities, including sponsorships, in-kind donations, and information booths.
16 No moneys appropriated in Section 1 of the act from dedicated funds shall
17 be used for conference related activities, unless otherwise allowed for in
18 Idaho Code.

19 SECTION 6. PAYMENT OF BANK SERVICE FEES. Of the amount appropriated in
20 Section 1 of this act, \$435,900 or so much thereof as is necessary, is to be
21 used solely and only for the payment of bank service fees for the period July
22 1, 2013, through June 30, 2014.
