SENATE BILL NO. 1173

BY FINANCE COMMITTEE

AN ACT 1 REDUCING THE APPROPRIATION TO THE DEPARTMENT OF LABOR FOR FISCAL YEAR 2015; 2 APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF LABOR FOR FISCAL 3 YEAR 2015; APPROPRIATING MONEYS TO THE DEPARTMENT OF LABOR FOR FIS-4 5 CAL YEAR 2016; LIMITING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT POSITIONS; PROVIDING AN APPROPRIATION AND TRANSFER OF MONEYS TO THE 6 WORKFORCE DEVELOPMENT TRAINING FUND; PROVIDING LEGISLATIVE INTENT FOR 7 LOCAL DEPARTMENT OF LABOR OFFICES; PROVIDING LEGISLATIVE INTENT ON AC-8 TIVITIES OF THE WORKFORCE DEVELOPMENT TRAINING FUND; AND DECLARING AN 9 10 EMERGENCY.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. Notwithstanding any other provision of law to the contrary, the appropriation made to the Department of Labor, for the Employment Services Program in Section 1, Chapter 301, Laws of 2014, from the Employment Security Special Administration Fund, is hereby reduced by \$3,000,000 for operating expenditures, for the period July 1, 2014, through June 30, 2015.

SECTION 2. In addition to the appropriation made in Section 1, Chapter 301, Laws of 2014, and any other appropriation provided for by law, there is hereby appropriated to the Department of Labor, for the Employment Services Program, the following amounts to be expended for the designated expense classes, from the listed funds for the period July 1, 2014, through June 30, 2015:

SECTION 4. FTP AUTHORIZATION. In accordance with Section 67-3519, Idaho Code, the Department of Labor is authorized no more than seven hundred (700) full-time equivalent positions at any point during the period July 1, 2015, through June 30, 2016, unless specifically authorized by the Governor. The Joint Finance-Appropriations Committee will be notified promptly of any increased positions so authorized.

SECTION 5. Notwithstanding Section 72-519, Idaho Code, on July 1, 2015, or as soon thereafter as is practicable, the State Controller shall transfer the sum of three million dollars (\$3,000,000) from the Industrial Administration Fund to the Workforce Development Training Fund for the purpose of providing Industry Sector grants.

SECTION 6. LEGISLATIVE INTENT. It is the intent of the Legislature that during the time period July 1, 2015, to June 30, 2016, the Department of Labor shall maintain the same number of local offices and provide the same or similar level of service as provided on July 1, 2014. Further, the Department of Labor shall report to the Joint Finance-Appropriations Committee, at the committee's 2015 fall interim meeting, and detail the gap between necessary resources and the current level of service to maintain the same number of local offices. Additionally, the department report shall include recommendations to fund these services.

SECTION 7. LEGISLATIVE INTENT. It is the intent of the Legislature that during the Second Regular Session of the Sixty-third Idaho Legislature, the Department of Labor shall report to the Joint Finance-Appropriations Committee on activities of the Workforce Development Training Fund. The report shall include results of employment for enrollees in the program, their wages before and after training, duration of employment, relation of training to field of employment, and detail how the money was expended.

SECTION 8. An emergency existing therefor, which emergency is hereby declared to exist, Sections 1 and 2 of this act shall be in full force and effect on and after passage and approval.
