AN ACT

1 APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF ADMINISTRATION FOR
2 FISCAL YEAR 2015; APPROPRIATING MONEYS TO THE DEPARTMENT OF ADMINISTRATION FOR FISCAL YEAR 2016; LIMITING THE NUMBER OF AUTHORIZED FULL-TIME
3 EQUIVALENT POSITIONS; PROVIDING A DEDICATED FUND CASH TRANSFER; PROVIDING FOR NOTIFICATION OF CONTRACT RENEWALS OR EXTENSIONS; DIRECTING
4 CONTINUATION OF THE HEALTH INSURANCE PREMIUM FOR STATE EMPLOYEES;
5 PROVIDING LEGISLATIVE INTENT REGARDING BROADBAND CONNECTIVITY; PROVIDING LEGISLATIVE INTENT REGARDING ISSUANCE OF CONTRACTS RELATING TO
6 THE IDAHO EDUCATION NETWORK; PROVIDING LEGISLATIVE INTENT REGARDING
7 ISSUANCE OF CONTRACTS RELATING TO BROADBAND FOR STATE AGENCIES; AND
8 DECLARING AN EMERGENCY.

13 Be It Enacted by the Legislature of the State of Idaho:

14 SECTION 1. In addition to the appropriation made in Section 1, Chapter 227, Laws of 2014, and any other appropriation provided for by law, there
15 is hereby appropriated \$100,000 from the Federal Surplus Property Revolving Fund to the Department of Administration, for the Purchasing Program to
16 be expended for operating expenditures, for the period July 1, 2014, through
17 June 30, 2015.

20 SECTION 2. There is hereby appropriated to the Department of Administration, the following amounts to be expended according to the designated
21 programs and expense classes, from the listed funds for the period July 1,
22 2015, through June 30, 2016:

30 SECTION 3. FTP AUTHORIZATION. In accordance with Section 67-3519,
31 Idaho Code, the Department of Administration is authorized no more than one
32 hundred thirty-nine and one-half (139.5) full-time equivalent positions
33 at any point during the period July 1, 2015, through June 30, 2016, unless
34 specifically authorized by the Governor. The Joint Finance-Appropriations
35 Committee will be notified promptly of any increased positions so autho-
36 rized.

1 SECTION 4. CASH TRANSFER. There is hereby appropriated to the Depart-
2 ment of Administration and the State Controller shall transfer \$1,737,500
3 from the Permanent Building Fund to the Administrative and Accounting Ser-
4 vices Fund on July 1, 2015, or as soon thereafter as necessary, for the Public
5 Officials' Capitol Mall Facilities payment in the Division of Public Works
6 due in fiscal year 2016.

7 SECTION 5. NOTIFICATION OF CONTRACT RENEWALS OR EXTENSIONS. The direc-
8 tor of the department shall notify the Legislature prior to any contract ex-
9 tensions or renewals in excess of \$1,000,000. As part of the budget submis-
10 sion process, the department shall submit a list of contracts due for renewal
11 in the upcoming fiscal year that exceed \$1,000,000 on an annual basis. Fur-
12 ther, the director shall notify the members of legislative leadership, the
13 JFAC chairmen and the germane committee chairmen, in writing, of any pro-
14 posed early contract renewal or extension at least 90 days prior to signing
15 the contract.

16 SECTION 6. HEALTH INSURANCE PREMIUM. The Office of Group Insurance
17 shall maintain the current health insurance program structure and benefit
18 package for state employees. The office shall also maintain the employer
19 and employee cost-sharing split recommended by the Governor and the Legisla-
20 ture's Joint Change in Employee Compensation Committee.

21 SECTION 7. LEGISLATIVE INTENT REGARDING BROADBAND CONNECTIVITY.
22 Notwithstanding Sections 67-5745D and 67-5745E, Idaho Code, money for
23 broadband services for schools is provided for in the appropriation made
24 to the Superintendent of Public Instruction for the period July 1, 2015,
25 through June 30, 2016.

26 SECTION 8. LEGISLATIVE INTENT REGARDING ISSUANCE OF CONTRACTS RELAT-
27 ING TO THE IDAHO EDUCATION NETWORK. Notwithstanding Sections 67-5745D and
28 67-5745E, Idaho Code, the Department of Administration shall not enter into
29 any contracts relating to educational services previously provided under
30 the Idaho Education Network until a longer-term policy direction is estab-
31 lished by this Legislature in concert with the Governor.

32 SECTION 9. LEGISLATIVE INTENT REGARDING ISSUANCE OF CONTRACTS RELAT-
33 ING TO BROADBAND FOR STATE AGENCIES. It is the intent of the Legislature
34 that, prior to the expiration of the six-month emergency contract currently
35 in place for broadband-related services at state agencies, the Department of
36 Administration shall analyze and justify the cost, benefits, and flexibil-
37 ity of a statewide contract, as compared to individual contracts issued by
38 state agencies, for the purchase of broadband and related services for state
39 agencies. Said analysis and justification may include, but is not limited
40 to, issuance of a Request for Information or Request for Proposal and the De-
41 partment of Administration is hereby directed to issue contracts based on
42 the results of said analysis. In addition, the Department of Administration
43 shall not enter into any contract with an initial term, or a renewal option,
44 that is longer than one year until a longer-term policy direction is estab-
45 lished by this Legislature in concert with the Governor.

1 SECTION 10. An emergency existing therefor, which emergency is hereby
2 declared to exist, Sections 1 and 8 of this act shall be in full force and ef-
3 fect on and after passage and approval.
