AN ACT

1 RELATING TO THE APPROPRIATION TO THE PUBLIC SCHOOLS EDUCATIONAL SUPPORT PRO-
2 GRAM/DIVISION OF ADMINISTRATORS FOR FISCAL YEAR 2016; PROVIDING FOR EX-
3 PENDITURES TO THE PUBLIC SCHOOLS EDUCATIONAL SUPPORT PROGRAM/DIVISION
4 OF ADMINISTRATORS FOR FISCAL YEAR 2016; APPROPRIATING GENERAL FUND MON-
5 EYS FOR TRANSFER TO THE PUBLIC SCHOOL INCOME FUND; APPROPRIATING FUNDS
6 TO THE PUBLIC SCHOOLS EDUCATIONAL SUPPORT PROGRAM/DIVISION OF ADMINIS-
7 TRATORS FOR FISCAL YEAR 2016; AMENDING SECTION 33-1004E, IDAHO CODE, AS
8 AMENDED IN SECTION 8 OF HOUSE BILL NO. 296, AS ENACTED BY THE FIRST REG-
9 ULAR SESSION OF THE SIXTY-THIRD IDAHO LEGISLATURE, TO INCREASE THE BASE
10 SALARY FOR ADMINISTRATORS; AND LIMITING THE DISTRIBUTION TO SCHOOL DIS-
11 TRICTS AND CHARTER SCHOOLS FOR STRATEGIC PLANNING AND TRAINING.

13 Be It Enacted by the Legislature of the State of Idaho:

14 SECTION 1. The following amount shall be expended for the Public
15 Schools Educational Support Program/Division of Administrators for the pe-
16 riod July 1, 2015, through June 30, 2016:

19 SECTION 2. There is hereby appropriated the following amount to be
20 transferred to the Public School Income Fund for the period July 1, 2015,
21 through June 30, 2016:

24 SECTION 3. There is hereby appropriated to the Public Schools Educa-
25 tional Support Program/Division of Administrators the following amount to
26 be expended from the listed fund for the period July 1, 2015, through June 30,
27 2016:

30 SECTION 4. That Section 33-1004E, Idaho Code, as amended in Section 8
31 of House Bill No. 296, as enacted by the First Regular Session of the Sixty-
32 third Idaho Legislature, be, and the same is hereby amended to read as fol-
33 lows:

1 33-1004E. DISTRICT'S SALARY-BASED APPORTIONMENT. Each district shall
2 be entitled to a salary-based apportionment calculated as provided in this
3 section.

4 (1) To determine the apportionment for instructional staff, take
5 the amounts indicated on the career ladder table plus the amounts associ-
6 ated with the additional education allocation amounts pursuant to section
7 33-1004B, Idaho Code, and calculate the weighted average. The amount so
8 determined shall be multiplied by the district staff allowance for instruc-
9 tional staff determined as provided in section 33-1004(2), Idaho Code.
10 Full-time instructional staff salaries shall be determined from a salary
11 schedule developed by each district and submitted to the state department of
12 education. No full-time instructional staff member shall be paid less than
13 the minimum dollar amount on the career ladder residency compensation rung
14 pursuant to section 33-1004B, Idaho Code, for the applicable fiscal year.
15 If an instructional staff member has been certified by the national board
16 for professional teaching standards, the staff member shall receive two
17 thousand dollars (\$2,000) per year for five (5) years from the year in which
18 national board certification was earned. The district staff allotment shall
19 be increased by two thousand dollars (\$2,000) for each national board cer-
20 tified instructional staff person and pupil service staff member who earned
21 national board certification; provided however, that no such awards shall be
22 paid for the period July 1, 2010, through June 30, 2011, nor shall any lia-
23 bilities accrue or payments be made pursuant to this section in the future to
24 any individuals who would have otherwise qualified for a payment during this
25 stated time period. The resulting amount is the district's salary-based
26 apportionment for instructional staff and pupil service staff. For purposes
27 of this section, teachers qualifying for the salary increase shall be those
28 who have been recognized as national board certified teachers as of July 1 of
29 each year.

30 (2) To determine the apportionment for pupil service staff, first de-
31 termine the district average experience and education index by placing all
32 eligible district certificated pupil service employees on the statewide
33 index pursuant to section 33-1004A, Idaho Code. The resulting average is the
34 district index. The district pupil service staff index shall be multiplied
35 by the instructional base salary of twenty-three thousand three hundred
36 fifty-four dollars (\$23,354). The amount so determined shall be multiplied
37 by the district staff allowance for pupil service staff determined pursuant
38 to section 33-1004(3), Idaho Code. The pupil service staff salary alloca-
39 tion shall be further increased by the amount necessary for each full-time
40 equivalent pupil service staff member placed on the experience and education
41 index to be allocated at least the minimum salary mandated by this section.
42 Full-time pupil service staff salaries shall be determined from a salary
43 schedule developed by each district and submitted to the state department of
44 education. The resulting amount is the district's salary-based apportion-
45 ment for pupil service staff. No full-time pupil service staff member shall
46 be paid less than thirty-one thousand seven hundred fifty dollars (\$31,750).

47 (3) To determine the apportionment for district administrative staff,
48 first determine the district average experience and education index by plac-
49 ing all eligible certificated administrative employees on the statewide in-
50 dex provided in section 33-1004A, Idaho Code. The resulting average is the

1 district index. Districts with an index above the state average index shall
2 receive their actual index but not more than the state average plus .03 for
3 the school year 1994-95, and shall receive their actual index but not more
4 than the state average index plus .06 for the 1995-96 school year, and there-
5 after shall receive their actual district index. The district administra-
6 tive staff index shall be multiplied by the base salary of ~~thirty-two~~thirty
7 thousand one hundred ~~fifty-one~~ sixteen dollars (~~\$32,151~~\$33,116). The amount
8 so determined shall be multiplied by the district staff allowance for admin-
9 istrative staff determined as provided in section 33-1004(4), Idaho Code.
10 The resulting amount is the district's salary-based apportionment for ad-
11 ministrative staff.

12 (4) To determine the apportionment for classified staff, multiply
13 nineteen thousand two hundred forty-nine dollars (\$19,249) by the district
14 classified staff allowance determined as provided in section 33-1004(5),
15 Idaho Code. The amount so determined is the district's apportionment for
16 classified staff.

17 (5) The district's salary-based apportionment shall be the sum of the
18 apportionments calculated in subsections (1), (2), (3) and (4) of this sec-
19 tion, plus the benefit apportionment as provided in section 33-1004F, Idaho
20 Code.

21 SECTION 5. LEGISLATIVE INTENT. It is the intent of the Legislature that
22 notwithstanding Section 33-320, Idaho Code, the distribution to each school
23 district and charter school for strategic planning and training shall be up
24 to \$4,000 for the period July 1, 2015, to June 30, 2016.
