28 16, TITLE 33, IDAHO CODE, BY THE ADDITION OF A NEW SECTION 33-1627, IDAHO
29 CODE, TO PROVIDE PROVISIONS RELATING TO ONLINE COURSES AND MOBILE COM-
30 PUTING DEVICES AND TO PROVIDE FOR CERTAIN EXPENDITURES OR DISTRIBUTIONS
31 OF MONEYS; AMENDING CHAPTER 52, TITLE 33, IDAHO CODE, BY THE ADDITION
32 OF A NEW SECTION 33-5216, IDAHO CODE, TO PROVIDE PROVISIONS RELATING TO
33 PUBLIC POSTSECONDARY INSTITUTIONS BEING AUTHORIZED TO OPERATE PUBLIC
34 CHARTER HIGH SCHOOLS; TO PROVIDE THAT NOTHING IN THIS ACT SHALL PREVENT
35 THE LEGISLATURE FROM ADJUSTING COMPONENTS OF CERTAIN FUNDING FORMULAS
36 PURSUANT TO THE NEEDS OF PUBLIC SCHOOLS AND THE CONSTITUTIONAL REQUIRE-
37 MENT THAT THE STATE MAINTAIN A BALANCED BUDGET; PROVIDING SEVERABILITY;
38 AND PROVIDING EFFECTIVE DATES.

40 Be It Enacted by the Legislature of the State of Idaho:

41 SECTION 1. That Section 33-125, Idaho Code, be, and the same is hereby
42 amended to read as follows:

1 33-125. STATE DEPARTMENT OF EDUCATION -- CREATION -- DUTIES. There is
 2 hereby established as an executive agency of the state board of education a
 3 department known as the state department of education. The state superin-
 4 tendent shall serve as the executive officer of such department and shall
 5 have the responsibility for carrying out policies, procedures and duties au-
 6 thorized by law or established by the state board of education for all ele-
 7 mentary and secondary school matters, and to ~~administer grants for the pro-~~
 8 ~~motion of science education as provided in sections 33-128 and 33-129, Idaho~~
 9 ~~Code~~ post a fiscal report card on each school district and charter school on
 10 the department's internet site. The department shall perform the duties as-
 11 signed to it as specified in section 67-5745D, Idaho Code, relating to the
 12 Idaho education network.

13 SECTION 2. That Section 33-129, Idaho Code, be, and the same is hereby
 14 repealed.

15 SECTION 3. That Section 33-357, Idaho Code, be, and the same is hereby
 16 amended to read as follows:

17 33-357. CREATION OF INTERNET BASED EXPENDITURE WEBSITE. (1) As used
 18 in this section, unless otherwise required:

19 (a) "Education provider" means:

- 20 (i) A school district, including a specially chartered district
- 21 organized and existing pursuant to law;
- 22 (ii) A cooperative services agency ~~or intermediate school dis-~~
- 23 ~~trict;~~
- 24 (iii) A public charter school authorized pursuant to state law;
- 25 (iv) A publicly funded governmental entity established by the
- 26 state for the express purpose of providing online courses.

27 (b) "Entity" means a corporation, association, union, limited liabil-
 28 ity company, limited liability partnership, grantee, contractor, local
 29 government or other legal entity, including a nonprofit corporation or
 30 an employee of the education provider.

31 (c) "Public record" shall have the same meaning as set forth in chapter
 32 3, title 9, Idaho Code.

33 (2) (a) No later than December 1, 2011, each education provider shall
 34 develop and maintain a publicly available website where the education
 35 provider's expenditures are posted in a nonsearchable PDF format, a
 36 searchable PDF format, a spreadsheet or in a database format.

37 (b) The internet based website shall include the following data con-
 38 cerning all expenditures made by the education provider:

- 39 (i) The name and location or address of the entity receiving mon-
- 40 neys;
- 41 (ii) The amount of expended moneys;
- 42 (iii) The date of the expenditure;
- 43 (iv) A description of the purpose of the expenditure, unless the
- 44 expenditure is self-describing;
- 45 (v) Supporting contracts and performance reports upon which the
- 46 expenditure is related when these documents already exist; ~~and~~
- 47 (vi) To the extent possible, a unique identifier for each expen-
- 48 diture;

1 (vii) The annual budget approved by the education provider's gov-
 2 erning board, to be posted within thirty (30) days after its ap-
 3 proval; and

4 (viii) Any current master labor agreements approved by the educa-
 5 tion provider's governing board.

6 (c) The expenditure data shall be provided in an open structured data
 7 format that may be downloaded by the user.

8 (d) The internet based website shall contain only information that is a
 9 public record or that is not confidential or otherwise exempt from pub-
 10 lic disclosure pursuant to state or federal law.

11 (3) The education provider shall:

12 (a) Update the expenditures contained on the internet based website at
 13 least monthly;

14 (b) Archive all expenditures, which shall remain accessible and on the
 15 internet based website for a number of years, consistent with state law
 16 regarding keeping and retention of records;

17 (c) Make the internet based website easily accessible from the main
 18 page of the education provider's website; and

19 (d) The website shall include those records beginning on the effective
 20 date of this act on July 1, 2011, and all data prior to that date shall be
 21 available by way of a public records request.

22 SECTION 4. That Section 33-1002, Idaho Code, be, and the same is hereby
 23 amended to read as follows:

24 33-1002. EDUCATIONAL SUPPORT PROGRAM. The educational support pro-
 25 gram is calculated as follows:

26 (1) State Educational Support Funds. Add the state appropriation, in-
 27 cluding the moneys available in the public school income fund, together with
 28 all miscellaneous revenues to determine the total state funds.

29 (2) From the total state funds subtract the following amounts needed
 30 for state support of special programs provided by a school district:

31 (a) Pupil tuition-equivalency allowances as provided in section
 32 33-1002B, Idaho Code;

33 (b) Transportation support program as provided in section 33-1006,
 34 Idaho Code;

35 (c) Feasibility studies allowance as provided in section 33-1007A,
 36 Idaho Code;

37 (d) The approved costs for border district allowance, provided in sec-
 38 tion 33-1403, Idaho Code, as determined by the state superintendent of
 39 public instruction;

40 (e) The approved costs for exceptional child approved contract al-
 41 lowance, provided in subsection 2. of section 33-2004, Idaho Code, as
 42 determined by the state superintendent of public instruction;

43 (f) Certain expectant and delivered mothers allowance as provided in
 44 section 33-2006, Idaho Code;

45 (g) Salary-based apportionment calculated as provided in sections
 46 33-1004 through 33-1004F, Idaho Code;

47 (h) Unemployment insurance benefit payments according to the provi-
 48 sions of section 72-1349A, Idaho Code;

6 In applying these tables to any given separate attendance unit, no
7 school district shall receive less total money than it would receive if it
8 had a lesser average daily attendance in such separate attendance unit.
9 In applying the kindergarten table to a kindergarten program of less days
10 than a full school year, the support unit allowance shall be in ratio to
11 the number of days of a full school year. The tables for exceptional edu-
12 cation and alternative school secondary support units shall be applicable
13 only for programs approved by the state department of education following
14 rules established by the state board of education. Moneys generated from
15 computation of support units for alternative schools shall be utilized for
16 alternative school programs. School district administrative and facility
17 costs may be included as part of the alternative school expenditures.

18 (5) State Distribution Factor per Support Unit. Divide educational
19 support program distribution funds, after subtracting the amounts necessary
20 to pay the obligations specified in subsection (2) of this section, by the
21 total state support units to secure the state distribution factor per sup-
22 port unit.

23 (6) District Support Units. The number of support units for each school
24 district in the state shall be determined as follows:

25 (a) (i) Divide the actual average daily attendance, excluding stu-
26 dents approved for inclusion in the exceptional child educational
27 program, for the administrative schools and each of the separate
28 schools and attendance units by the appropriate divisor from the
29 tables of support units in this section, then add the quotients
30 to obtain the district's support units allowance for regular stu-
31 dents, kindergarten through grade 12 including alternative school
32 secondary students. Calculations in application of this subsec-
33 tion shall be carried out to the nearest tenth.

34 (ii) Divide the combined totals of the average daily attendance
35 of all preschool, kindergarten, elementary, secondary, juvenile
36 detention center students and students with disabilities approved
37 for inclusion in the exceptional child program of the district by
38 the appropriate divisor from the table for computation of excep-
39 tional education support units to obtain the number of support
40 units allowed for the district's approved exceptional child pro-
41 gram. Calculations for this subsection shall be carried out to the
42 nearest tenth when more than one (1) unit is allowed.

43 (iii) The total number of support units of the district shall be
44 the sum of the total support units for regular students, subsec-
45 tion (6) (a) (i) of this section, and the support units allowance
46 for the approved exceptional child program, subsection (6) (a) (ii)
47 of this section.

1 (b) Total District Allowance Educational Program. Multiply the dis-
 2 trict's total number of support units, carried out to the nearest tenth,
 3 by the state distribution factor per support unit and to this product
 4 add the approved amount of programs of the district provided in subsec-
 5 tion (2) of this section to secure the district's total allowance for
 6 the educational support program.

7 (c) District Share. The district's share of state apportionment is the
 8 amount of the total district allowance, subsection (6) (b) of this sec-
 9 tion.

10 (d) Adjustment of District Share. The contract salary of every noncer-
 11 tificated teacher shall be subtracted from the district's share as cal-
 12 culated from the provisions of subsection (6) (c) of this section.

13 (7) Property Tax Computation Ratio. In order to receive state funds
 14 pursuant to this section a charter district shall utilize a school mainte-
 15 nance and operation property tax computation ratio for the purpose of cal-
 16 culating its maintenance and operation levy, that is no greater than that
 17 which it utilized in tax year 1994, less four-tenths of one percent (.4%). As
 18 used herein, the term "property tax computation ratio" shall mean a ratio de-
 19 termined by dividing the district's certified property tax maintenance and
 20 operation budget by the actual or adjusted market value for assessment pur-
 21 poses as such values existed on December 31, 1993. Such maintenance and op-
 22 eration levy shall be based on the property tax computation ratio multiplied
 23 by the actual or adjusted market value for assessment purposes as such values
 24 existed on December 31 of the prior calendar year.

25 SECTION 5. That Section 33-1002, Idaho Code, be, and the same is hereby
 26 amended to read as follows:

27 33-1002. EDUCATIONAL SUPPORT PROGRAM. The educational support pro-
 28 gram is calculated as follows:

29 (1) State Educational Support Funds. Add the state appropriation, in-
 30 cluding the moneys available in the public school income fund, together with
 31 all miscellaneous revenues to determine the total state funds.

32 (2) From the total state funds subtract the following amounts needed
 33 for state support of special programs provided by a school district:

34 (a) Pupil tuition-equivalency allowances as provided in section
 35 33-1002B, Idaho Code;

36 (b) Transportation support program as provided in section 33-1006,
 37 Idaho Code;

- 3 (i) For public school technology as provided in section 33-1022, Idaho
- 4 Code;
- 5 (j) For employee severance payments as provided in section 33-521,
- 6 Idaho Code;
- 7 (k) For distributions to the Idaho digital learning academy as provided
- 8 in section 33-1020, Idaho Code;
- 9 (l) For dual credit courses as provided in section 33-1626, Idaho Code;
- 10 (m) For additional math and science courses for high school students as
- 11 provided in section 33-1021, Idaho Code;
- 12 (n) For costs associated with mobile computing devices and teacher
- 13 training as provided in section 33-1627, Idaho Code;
- 14 (o) For certificated employee severance payment reimbursement as pro-
- 15 vided in section 33-515B, Idaho Code;
- 16 (p) For pay for performance as provided in section 33-1004I, Idaho
- 17 Code;
- 18 (~~eq~~) For the support of provisions that provide a safe environment con-
- 19 ducive to student learning and maintain classroom discipline, an allo-
- 20 cation of \$300 per support unit; and
- 21 (~~pr~~) Any additional amounts as required by statute to effect adminis-
- 22 trative adjustments or as specifically required by the provisions of
- 23 any bill of appropriation;

24 to secure the total educational support distribution funds.

25 (3) Average Daily Attendance. The total state average daily attendance
 26 shall be the sum of the average daily attendance of all of the school dis-
 27 tricts of the state. The state board of education shall establish rules set-
 28 ting forth the procedure to determine average daily attendance and the time
 29 for, and method of, submission of such report. Average daily attendance cal-
 30 culation shall be carried out to the nearest hundredth. Computation of av-
 31 erage daily attendance shall also be governed by the provisions of section
 32 33-1003A, Idaho Code.

33 (4) Support Units. The total state support units shall be determined
 34 by using the tables set out hereafter called computation of kindergarten
 35 support units, computation of elementary support units, computation of sec-
 36 ondary support units, computation of exceptional education support units,
 37 and computation of alternative school secondary support units. The sum of
 38 all of the total support units of all school districts of the state shall be
 39 the total state support units.

35 33-1002A. FRACTIONAL AVERAGE DAILY ATTENDANCE. (1) For students at-
36 tending school in more than one (1) school district or public charter school,
37 or who are enrolled in one (1) or more online courses in which the student's
38 home school district or public charter school is not the content provider,
39 attendance shall be counted and divided based on the portion of the student's
40 daily attendance time that is spent in attendance at each school district,
41 public charter school or online course. This provision shall not apply to:

42 (a) An online course in which the school district or public charter
43 school has a contract in place for the provision of online courses.

44 (b) Any online course which causes the total number of courses in which
45 a student is enrolled to exceed the maximum number of periods of in-
46 struction offered at the school in which the student is enrolled. If a
47 student is enrolled in multiple online courses and one (1) or more on-
48 line course falls within this limitation and one (1) or more fall beyond
49 it, then the most expensive courses shall be subject to fractional aver-

1 age daily attendance. School districts and public charter schools may
2 choose to pay for any online courses that fall beyond the limitation of
3 this paragraph, at their discretion. The parents or guardians of stu-
4 dents shall be responsible for paying the cost of any online courses in
5 which the student is enrolled beyond the limitation of this paragraph,
6 unless such cost has been paid by the student's school district or pub-
7 lic charter school. A student's home school district or public charter
8 school shall notify the student's parent or guardian at the time of reg-
9 istration if any online courses in which the student is enrolling exceed
10 the maximum provided in this paragraph.

11 (2) For online courses subject to fractional counting and division, the
12 average daily attendance shall be counted and funded as part of the student's
13 home school district or public charter school attendance. However, the
14 state department of education shall identify the fraction attributable to
15 such attendance for each student and furnish the home school district or pub-
16 lic charter school with a dollar amount of funding attributable to each such
17 fraction. The home school district or public charter school shall then remit
18 two-thirds (2/3) of such amount to each online course content provider.

19 (3) For the purposes of this section and section 33-1627, Idaho Code,
20 the term "online course" means a course which delivers a sequential program
21 of synchronous and/or asynchronous instruction primarily through the use of
22 technology, in which the instructor is not physically located at the school
23 or place in which the student is receiving instruction. Nothing in this def-
24 inition shall prohibit a blended course that includes face-to-face, in per-
25 son instruction, provided that a majority of the instruction is delivered as
26 stated herein.

27 SECTION 7. That Section 33-1004, Idaho Code, be, and the same is hereby

42 (3) Determine the administrative staff allowance by multiplying the
43 support units by .075;

44 (4) Determine the classified staff allowance by multiplying the sup-
45 port units by .375;

46 (5) Additional conditions governing staff allowance:

47 (a) In determining the number of staff in subsections (2), (3) and (4)
48 of this section, a district may contract separately for services to be
49 rendered by nondistrict employees and such employees may be counted

1 in the staff allowance. A "nondistrict employee" means a person for
2 whom the school district does not pay the employer's obligations for
3 employee benefits. When a district contracts for the services of a
4 nondistrict employee, only the salary portion of the contract shall be
5 allowable for computations.

6 (b) If there are circumstances preventing eligible use of staff al-
7 lowance to which a district is entitled as provided in subsections (2)
8 and (3) of this section, an appeal may be filed with the state depart-

23 support units, the instructional staff allowance shall be calcu-

26 the instructional staff allowance, the staff allowance shall be
27 increased as provided in paragraphs (i) and (ii) of this subsec-
28 tion, and by an additional one-half (1/2) instructional staff al-
29 lowance.

30 (d) For any school district with one (1) or more separate secondary
31 schools serving grades nine (9) through twelve (12), the instructional
32 staff allowance shall be increased by two (2) additional instructional
33 staff allowances for each such separate secondary school.

34 (e) Only instructional, administrative and classified personnel
35 compensated by the school district from the general maintenance and
36 operation fund of the district shall be included in the calculation
37 of staff allowance or in any other calculations based upon staff, in-
38 cluding determination of the experience and education multiplier, the
39 reporting requirements, or the district's salary-based apportionment
40 calculation. No food service staff or transportation staff shall be
41 included in the staff allowance.

42 (f) A district may utilize up to ~~five~~ fifteen percent (15%) of the mon-
43 eys associated with positions funded pursuant to subsection (2) of this
44 section to pay another school district or public charter school for in-
45 structional services or to defray the cost of providing virtual educa-
46 tion coursework, including virtual dual credit coursework, without a

48 (g) For the period July 1, 2009, through June 30, 2011, only, a district
49 may shift up to five percent (5%) of the positions funded pursuant to

subsection (2) of this section to federal funds, without a reduction in the number of funded positions being imposed.

(h) A district may employ fewer positions than funded pursuant to subsection (2) of this section, without a reduction in the number of funded positions being imposed, subject to the following limits on the percent of such positions that may be reduced:

Such a waiver shall be limited to one (1) year, but may be renewed upon showing of continuing justification.

37 sources and software linked to state and local curricula, including
38 model lesson plans, content and formative and summative assessments
39 tied to rigorous college and career-ready standards and safe and secure
40 online knowledge sharing and collaboration systems.

41 (c) Moneys shall be expended or distributed for classroom technology
42 that assists teachers in the effective and efficient delivery of in-
43 struction. At least ninety-seven percent (97%) of the moneys expended
44 or distributed for this paragraph shall be distributed to school dis-

1 tricts, public charter schools and the Idaho school for the deaf and
2 blind.

3 (d) Moneys shall be expended or distributed for professional devel-
4 opment and training that promotes the effective use of technology by
5 students, staff and parents, the integration of technology into pub-
6 lic school curricula and instructional methods, and the development of
7 plans at the school, district and statewide level for the improved use
8 and integration of technology in learning. As part of this paragraph,
9 the superintendent of public instruction shall convene a task force
10 to study and develop plans for the implementation of online course re-
11 quirements, including the issue of online summer and overload courses,
12 and the provision and support of one-to-one mobile computing devices
13 for students, including an examination of the experience of other
14 states and school districts, beginning in the 2012-2013 school year,
15 and other topics determined by the task force chairman. The superinten-
16 dent of public instruction shall serve as the task force chairman, and
17 shall appoint to the task force, at a minimum, four (4) school district
18 superintendents, two (2) school district technology directors, two (2)
19 secondary school principals, one (1) school district business manager,
20 one (1) head of school of a public virtual charter school, one (1) head
21 of school of a traditional public charter school serving at least grades
22 9-12, two (2) secondary school classroom teachers, one (1) private sec-
23 tor education technology expert who is neither employed by, represents,
24 nor is an agent of any entity that provides online courses or mobile
25 computing devices and three (3) representatives of the business com-
26 munity. In addition, the Idaho house of representatives and the Idaho
27 senate shall each appoint two (2) members, and each of the following
28 organizations shall appoint one (1) individual to the task force: Idaho
29 education association, northwest professional educators, Idaho school
30 boards association, Idaho association of school administrators, Idaho
31 business coalition for education excellence, Idaho digital learning
32 academy and the office of the governor. The superintendent shall report
33 the findings, plans and recommendations of this task force, including
34 any recommendations for changes to statute or rule, to the senate and
35 house of representatives education committees by no later than January
36 31, 2012.

37 (4) The state superintendent of public instruction shall include
38 information on the uses, planned uses and impact of moneys distributed
39 pursuant to this section as part of the annual report required by section
40 33-4805, Idaho Code.

41 SECTION 14. That Chapter 16, Title 33, Idaho Code, be, and the same is
42 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
43 ignated as Section 33-1626, Idaho Code, and to read as follows:

44 33-1626. DUAL CREDIT FOR EARLY COMPLETERS. Students completing all
45 state high school graduation requirements, except the senior project, by
46 no later than the start of the twelfth grade shall be eligible for up to
47 thirty-six (36) postsecondary credits of dual credit courses during their
48 twelfth grade year. Average daily attendance shall be counted as normal
49 for such twelfth grade students for public school funding purposes. In ad-

1 dition, the state department of education shall distribute funds from the
2 moneys appropriated for the educational support program to defray the per
3 credit cost charged for such dual credit courses by accredited postsecondary
4 institutions. The amount so distributed shall not exceed seventy-five dol-
5 lars (\$75.00) per credit hour.

6 SECTION 15. That Chapter 16, Title 33, Idaho Code, be, and the same is
7 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
8 ignated as Section 33-1627, Idaho Code, and to read as follows:

9 33-1627. ONLINE COURSES -- MOBILE COMPUTING DEVICES AND TEACHER
10 TRAINING. (1) The legislature finds that in order to better provide students
11 with the skills that they will need to be successful as students, employees,
12 entrepreneurs and parents in the future, more exposure is needed to online
13 learning and informational environments.

14 (2) Beginning with the 2012-2013 school year, parents and guardians of
15 secondary students shall have the right to enroll such students in any online
16 course, with or without the permission of the school district or public char-
17 ter school in which the student is enrolled, provided the following criteria
18 are met:

19 (a) The course is offered by a provider accredited by the organization
20 that accredits Idaho high schools, or an organization whose accredi-
21 tation of providers is recognized by the organization that accredits
22 Idaho high schools;

23 (b) The state department of education has verified that the teacher is
24 certificated by the state of Idaho and is qualified to teach the course;

25 (c) The state department of education or the Idaho digital learning
26 academy has verified that the course meets state content standards;

27 (d) The parent or guardian registers the student for the course through
28 the school district or public charter school's normal registration
29 process, which shall be made to accommodate enrollment in courses meet-
30 ing the requirements of paragraphs (a) through (c) of this subsection.
31 Provided however, that school districts and public charter schools
32 shall accommodate such enrollment requests if a student's parent or
33 guardian makes such request no later than thirty (30) days prior to the
34 end of the term immediately previous to the one for which the student is
35 enrolling, or no later than the end of the school year, in the case of a
36 term ending at the end of the school year.

37 (3) A student's transcript at the school district or public charter
38 school at which the student is enrolled shall include the credits earned and
39 grades received by each student for any online courses taken pursuant to this
40 section.

41 (4) In order to assist in providing students with access to online
42 courses, the state department of education shall contract for the provi-
43 sion of mobile computing devices for the students and teachers of each high
44 school. Such devices shall be provided to all high school teachers beginning
45 in the 2012-2013 school year, unless the teacher already has a computing
46 device available and requests that one not be provided. Such devices for
47 teachers shall be replaced every four (4) years. Devices shall be provided
48 for high school students beginning in the 2013-2014 school year. The number
49 of devices provided to students each year shall be equal to one-third (1/3)

1 of the high school students through the 2015-2016 school year, after which
2 the number shall be equal to the number of ninth grade students. School dis-
3 tricts and public charter schools in which high school begins in tenth grade
4 may elect to have all of the provisions of this section that apply to ninth
5 grade students apply instead to tenth grade students. School districts and
6 public charter schools that already have one (1) modern functioning comput-
7 ing device for each student in each appropriate class in grades 9-12 who is
8 able to use such a device shall receive an allocation of funds equal to the
9 cost of purchasing mobile computing devices pursuant to this section, in
10 lieu of receiving such devices, to be used at the school district or public
11 charter school's discretion. The department shall use the same laws, rules
12 and policies in issuing and awarding such contract as would an executive
13 branch agency in which an appointed director reports directly to the gov-
14 ernor. Such devices shall include technology that provides for compliance
15 with the provisions of section 33-132, Idaho Code. Such contract shall also
16 provide for the maintenance, repair and technical support of such devices.
17 The cost of such contract and distributions made pursuant to this subsection
18 shall be paid from the moneys appropriated for the educational support pro-
19 gram. Each school district or public charter school shall develop a policy
20 on student use of the mobile computing devices outside of the school day.
21 Such policy shall be in compliance with the provisions of section 33-132,
22 Idaho Code. The state department of education shall develop a policy ad-
23 dressing the issue of damage, loss, repair and replacement of the mobile
24 computing devices.

25 (5) The state department of education shall expend or distribute an
26 amount equal to twelve (12) multiplied by the per statewide support unit
27 value of salary-based apportionment and discretionary funds for fiscal
28 year 2013 through fiscal year 2016, from the amount appropriated to the ed-
29 ucational support program, to train high school staff in the use of mobile
30 computing devices by students in the classroom, and the integration of such
31 use into the curriculum. For the purposes of this subsection, the support
32 units used to calculate this statewide figure shall be the statewide sup-
33 port units used to calculate the distribution of salary-based apportionment
34 funds in the current fiscal year.

35 (6) The state board of education shall promulgate rules to implement
36 the provisions of this section, including a requirement for online courses
37 needed for graduation beginning with the graduating class of 2016, and the
38 development of digital citizenship standards for students to which this
39 graduation requirement applies.

40 SECTION 16. That Chapter 52, Title 33, Idaho Code, be, and the same is
41 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
42 ignated as Section 33-5216, Idaho Code, and to read as follows:

43 33-5216. PUBLIC POSTSECONDARY INSTITUTIONS -- PUBLIC CHARTER HIGH
44 SCHOOLS. (1) Any public postsecondary institution located in this state is
45 hereby authorized to operate a public charter high school in Idaho. The pro-
46 visions of chapter 52, title 33, Idaho Code, shall apply to each such public
47 charter high school in the same manner and to the same extent as the provi-
48 sions of charter school law apply to other public charter schools, with the

1 exception of certain conditions and applications as specifically provided
2 in this section.

3 (2) With the consent of the state board of education, a public postsec-
4 ondary institution may petition to establish a public charter high school
5 to the public charter school commission or to the local board of trustees.
6 Any provision or reference to the public charter school commission found in
7 chapter 52, title 33, Idaho Code, shall mean, for the purposes of this sec-
8 tion, the state board of education.

9 (3) The president or chief executive officer of such postsecondary in-
10 stitution, or his designee(s), shall serve as the board of trustees of any
11 public charter high school opened for educational instruction pursuant to
12 this section.

13 (4) For the purposes of this section, the term "high school" means a
14 school serving any grades from ninth grade or higher.

15 SECTION 17. Nothing in this act shall prevent the Legislature from
16 adjusting any component of any public school funding formula in any fiscal
17 year, pursuant to the needs of public schools and the constitutional re-
18 quirement that the state of Idaho maintain a balanced budget.

19 SECTION 18. SEVERABILITY. The provisions of this act are hereby de-
20 clared to be severable and if any provision of this act or the application
21 of such provision to any person or circumstance is declared invalid for any
22 reason, such declaration shall not affect the validity of the remaining por-
23 tions of this act.

24 SECTION 19. Sections 1, 2, 3, 4, 7, 8, 9, 12, 13, 14, 15, 16, 17 and 18 of
25 this act shall be in full force and effect on and after July 1, 2011. Sections
26 5, 6, 10 and 11 of this act shall be in full force and effect on and after July
27 1, 2012.
