AN ACT

1 APPROPRIATING ADDITIONAL MONEYS TO THE SUPREME COURT FOR THE SUPREME COURT  
2 PROGRAM FOR FISCAL YEAR 2018; APPROPRIATING ADDITIONAL MONEYS TO THE  
3 SUPREME COURT FOR THE DISTRICT COURTS PROGRAM FOR FISCAL YEAR 2018; AP-  
4 PROPRIATING ADDITIONAL MONEYS TO THE SUPREME COURT FOR THE MAGISTRATES  
5 DIVISION PROGRAM FOR FISCAL YEAR 2018; APPROPRIATING ADDITIONAL MONEYS  
6 TO THE SUPREME COURT FOR THE COURT OF APPEALS PROGRAM FOR FISCAL YEAR  
7 2018; AND EXEMPTING APPROPRIATION FROM OBJECT AND PROGRAM TRANSFER LIM-  
8 ITATIONS.

10 Be It Enacted by the Legislature of the State of Idaho:

11 SECTION 1. In addition to the appropriation made in Section 1 of Senate  
12 Bill No. 1160, as enacted by the First Regular Session of the Sixty-fourth  
13 Idaho Legislature, and any other appropriation provided for by law, there  
14 is hereby appropriated to the Supreme Court for the Supreme Court program  
15 \$57,100 from the General Fund to be expended for personnel costs for the pe-  
16 riod July 1, 2017, through June 30, 2018, for the purpose of judicial salary  
17 increases.

18 SECTION 2. In addition to the appropriation made in Section 1 of Senate  
19 Bill No. 1160, as enacted by the First Regular Session of the Sixty-fourth  
20 Idaho Legislature, and any other appropriation provided for by law, there  
21 is hereby appropriated to the Supreme Court for the District Courts program  
22 \$250,000 from the General Fund to be expended for personnel costs for the pe-  
23 riod July 1, 2017, through June 30, 2018, for the purpose of judicial salary  
24 increases.

25 SECTION 3. In addition to the appropriation made in Section 1 of Senate  
26 Bill No. 1160, as enacted by the First Regular Session of the Sixty-fourth  
27 Idaho Legislature, and any other appropriation provided for by law, there is  
28 hereby appropriated to the Supreme Court for the Magistrates Division pro-  
29 gram \$348,000 from the General Fund to be expended for personnel costs for  
30 the period July 1, 2017, through June 30, 2018, for the purpose of judicial  
31 salary increases.

32 SECTION 4. In addition to the appropriation made in Section 1 of Senate  
33 Bill No. 1160, as enacted by the First Regular Session of the Sixty-fourth  
34 Idaho Legislature, and any other appropriation provided for by law, there  
35 is hereby appropriated to the Supreme Court for the Court of Appeals program  
36 \$52,700 from the General Fund to be expended for personnel costs for the pe-  
37 riod July 1, 2017, through June 30, 2018, for the purpose of judicial salary  
38 increases.

1           SECTION 5. EXEMPTIONS FROM OBJECT AND PROGRAM TRANSFER LIMITATIONS.  
2   For fiscal year 2018, the Supreme Court is hereby exempted from the provi-  
3   sions of Section 67-3511(1), (2) and (3), Idaho Code, allowing unlimited  
4   transfers between object codes and between programs, for all moneys appro-  
5   priated to it for the period July 1, 2017, through June 30, 2018. Legislative  
6   appropriations shall not be transferred from one fund to another fund unless  
7   expressly approved by the Legislature.
