SENATE BILL NO. 1211

BY FINANCE COMMITTEE

AN ACT

1 RELATING TO THE APPROPRIATION TO THE DEPARTMENT OF ADMINISTRATION FOR THE  
2 DIVISION OF PUBLIC WORKS FOR FISCAL YEAR 2019; PROVIDING FOR A GENERAL  
3 FUND CASH TRANSFER; APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT  
4 OF ADMINISTRATION FOR THE DIVISION OF PUBLIC WORKS FOR FISCAL YEAR 2019;  
5 PROVIDING FOR THE RETURN OF UNUSED MONEYS; EXEMPTING THE APPROPRIATION  
6 FROM OBJECT TRANSFER LIMITATIONS; AND DECLARING AN EMERGENCY.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. There is hereby appropriated and the State Controller shall  
10 transfer \$529,000 from the General Fund to the Permanent Building Fund as  
11 soon as practicable.

12 SECTION 2. In addition to the appropriation made in Section 1, Chapter  
13 302, Laws of 2018, and any other appropriation provided by law, there is  
14 hereby appropriated to the Department of Administration for the Division of  
15 Public Works \$529,000 from the Permanent Building Fund for the period July  
16 1, 2018, through June 30, 2019, for the purpose of the necessary renovation  
17 costs of the Borah Building or for other reasonable office space for the  
18 State Treasurer, for associated moving costs to relocate all, or part of,  
19 the office of the State Treasurer, and for any necessary capital outlay for  
20 computer or office equipment.

21 SECTION 3. RETURN OF UNUSED MONEYS. Notwithstanding the provisions of  
22 Section 5, Chapter 302, Laws of 2018, and any other provision of law to the  
23 contrary, of the amount appropriated in Section 2 of this act, the Division  
24 of Public Works shall notify the State Controller of any unexpended and un-  
25 encumbered moneys upon completion of the project and the State Controller  
26 shall transfer such moneys from the Permanent Building Fund to the General  
27 Fund as soon as practicable.

28 SECTION 4. EXEMPTIONS FROM OBJECT TRANSFER LIMITATIONS. The amount  
29 appropriated in Section 2 of this act is hereby exempted from the provisions  
30 of Section 67-3511(1) and (3), Idaho Code, allowing unlimited transfers  
31 between object codes. Legislative appropriations shall not be transferred  
32 from one fund to another fund unless expressly approved by the Legislature.

33 SECTION 5. An emergency existing therefor, which emergency is hereby  
34 declared to exist, this act shall be in full force and effect on and after its  
35 passage and approval.
