AN ACT

1 RELATING TO APPROPRIATIONS; APPROPRIATING AND TRANSFERRING MONEYS FROM THE
2 GENERAL FUND TO THE WORKFORCE DEVELOPMENT TRAINING FUND FOR FISCAL YEAR
3 2023; APPROPRIATING ADDITIONAL MONEYS TO THE WORKFORCE DEVELOPMENT
4 COUNCIL FOR FISCAL YEAR 2023; PROVIDING REAPPROPRIATION AUTHORITY; AP-
5 PROPRIATING AND TRANSFERRING MONEYS FROM THE GENERAL FUND TO THE PUBLIC
6 EDUCATION STABILIZATION FUND FOR FISCAL YEAR 2024; APPROPRIATING AND
7 TRANSFERRING MONEYS FROM THE GENERAL FUND TO THE BUDGET STABILIZATION
8 FUND FOR FISCAL YEAR 2024; APPROPRIATING AND TRANSFERRING MONEYS FROM
9 THE GENERAL FUND TO THE FIRE SUPPRESSION DEFICIENCY FUND FOR FISCAL YEAR
10 2024; APPROPRIATING AND TRANSFERRING MONEYS FROM THE GENERAL FUND TO
11 THE PEACE OFFICERS TRAINING FUND FOR FISCAL YEAR 2024; AND DECLARING AN
12 EMERGENCY AND PROVIDING AN EFFECTIVE DATE.

14 Be It Enacted by the Legislature of the State of Idaho:

15 SECTION 1. FISCAL YEAR 2023 CASH TRANSFER TO THE WORKFORCE DEVELOPMENT
16 TRAINING FUND. There is hereby appropriated and the Office of the State Con-
17 troller shall transfer \$15,000,000 from the General Fund to the Workforce
18 Development Training Fund as soon as practicable for the period July 1, 2022,
19 through June 30, 2023.

20 SECTION 2. In addition to the appropriation made in Section 1, Chap-
21 ter 249, Laws of 2022, and any other appropriation provided by law, there is
22 hereby appropriated to the Workforce Development Council \$15,000,000 from
23 the Workforce Development Training Fund to be expended for trustee and bene-
24 fit payments for the period July 1, 2022, through June 30, 2023, for the pur-
25 pose of semiconductor workforce grants.

26 SECTION 3. REAPPROPRIATION AUTHORITY. There is hereby reappropriated
27 to the Workforce Development Council any unexpended and unencumbered bal-
28 ances appropriated to the Workforce Development Council from the Workforce
29 Development Training Fund for the purpose of semiconductor workforce grants
30 for fiscal year 2023 in an amount not to exceed \$15,000,000 from the Work-
31 force Development Training Fund to be used for nonrecurring expenditures re-
32 lated to semiconductor workforce grants for the period July 1, 2023, through
33 June 30, 2024. The Office of the State Controller shall confirm the reappro-
34 priation amount with the Legislative Services Office prior to processing the
35 reappropriation authorized herein.

36 SECTION 4. FISCAL YEAR 2024 CASH TRANSFER TO THE PUBLIC EDUCATION STA-
37 BILIZATION FUND. There is hereby appropriated and the Office of the State
38 Controller shall transfer an amount not to exceed \$29,327,600 from the Gen-
39 eral Fund to the Public Education Stabilization Fund on August 1, 2023, or as
40 soon thereafter as practicable for the period July 1, 2023, through June 30,

1 2024. The actual amount transferred shall be the calculated amount to reach
2 the statutory limit of eight and one-third percent (8.334%) of the current
3 fiscal year's total appropriation of state funds for public school support
4 as found in Section 33-907, Idaho Code, as determined by the Office of the
5 State Controller in consultation with the State Department of Education and
6 the Legislative Services Office.

7 SECTION 5. FISCAL YEAR 2024 CASH TRANSFER TO THE BUDGET STABILIZATION
8 FUND. There is hereby appropriated and the Office of the State Controller
9 shall transfer \$32,363,200 from the General Fund to the Budget Stabilization
10 Fund on July 1, 2023, or as soon thereafter as practicable for the period July
11 1, 2023, through June 30, 2024.

12 SECTION 6. FISCAL YEAR 2024 CASH TRANSFER TO THE FIRE SUPPRESSION DEFICI-
13 CIENCY FUND. There is hereby appropriated and the Office of the State Con-
14 troller shall transfer \$68,715,900 from the General Fund to the Fire Sup-
15 pression Deficiency Fund on July 1, 2023, or as soon thereafter as practica-
16 ble for the period July 1, 2023, through June 30, 2024.

17 SECTION 7. FISCAL YEAR 2024 CASH TRANSFER TO THE PEACE OFFICERS TRAIN-
18 ING FUND. There is hereby appropriated and the Office of the State Controller
19 shall transfer \$550,000 from the General Fund to the Peace Officers Training
20 Fund on July 1, 2023, or as soon thereafter as practicable for the period July
21 1, 2023, through June 30, 2024.

22 SECTION 8. An emergency existing therefor, which emergency is hereby
23 declared to exist, Sections 1 and 2 of this act shall be in full force and ef-
24 fect on and after passage and approval, and Sections 3, 4, 5, 6, and 7 of this
25 act shall be in full force and effect on and after July 1, 2023.
