SENATE BILL NO. 1212

AN ACT

1 RELATING TO THE APPROPRIATION TO THE DEPARTMENT OF ADMINISTRATION FOR THE  
2 DIVISION OF PUBLIC WORKS FOR FISCAL YEAR 2019; PROVIDING FOR A GENERAL  
3 FUND CASH TRANSFER; APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT  
4 OF ADMINISTRATION FOR THE DIVISION OF PUBLIC WORKS FOR FISCAL YEAR 2019;  
5 PROVIDING FOR THE RETURN OF UNUSED MONEYS; PROVIDING FOR THE ACQUI-  
6 SITION OF AVAILABLE PROPERTIES; PROVIDING FOR CAPITOL MALL PROPERTY; AND  
7 DECLARING AN EMERGENCY.

9 Be It Enacted by the Legislature of the State of Idaho:

10 SECTION 1. There is hereby appropriated and the State Controller shall  
11 transfer \$1,955,000 from the General Fund to the Permanent Building Fund as  
12 soon as practicable.

13 SECTION 2. In addition to the appropriation made in Section 1, Chap-  
14 ter 302, Laws of 2018, and any other appropriation provided by law, there is  
15 hereby appropriated to the Department of Administration for the Division of  
16 Public Works \$1,955,000 from the Permanent Building Fund to be expended for  
17 capital outlay for the period July 1, 2018, through June 30, 2019, for the  
18 purpose of purchasing real property near or adjacent to the Capitol Mall.

19 SECTION 3. RETURN OF UNUSED MONEYS. Notwithstanding the provisions of  
20 Section 5, Chapter 302, Laws of 2018, and any other provision of law to the  
21 contrary, of the amount appropriated in Section 2 of this act, the Division  
22 of Public Works shall notify the State Controller of any unexpended and un-  
23 encumbered moneys upon completion of each project and the State Controller  
24 shall transfer such moneys from the Permanent Building Fund to the General  
25 Fund as soon as practicable.

26 SECTION 4. ACQUISITION OF AVAILABLE PROPERTIES. The total amount ap-  
27 propriated in Section 2 of this act, or so much thereof as is necessary, shall  
28 be used for the acquisition of available properties near or adjacent to the  
29 Capitol Mall area. The Department of Administration shall initiate purchase  
30 negotiations as soon as practicable and shall complete such purchase on be-  
31 half of and in the name of the state of Idaho.

32 SECTION 5. CAPITOL MALL PROPERTY. Any property acquired under Section  
33 2 of this act shall become part of the Capitol Mall and the Department of  
34 Administration shall promulgate rules as required to implement the same.  
35 Further, the department shall bring forth legislation during the next leg-  
36 islative session to specifically include the property as part of the Capitol  
37 Mall.

1           SECTION 6. An emergency existing therefor, which emergency is hereby  
2 declared to exist, this act shall be in full force and effect on and after its  
3 passage and approval.
