2 RELATING TO CIVIL ACTIONS; AMENDING SECTION 10-1111, IDAHO CODE, TO PROVIDE
3 FOR ORDERS RENEWING JUDGMENT, TO PROVIDE FOR LIENS THAT ARE CONTINUED,
4 TO PROVIDE FOR HOW ENTRY OF AN ORDER RENEWING JUDGMENT AFFECTS A CERTAIN
5 DATE, THE PRIORITY OF COLLECTION AND THE TIME LIMITATION AND TO CLARIFY
6 A PROVISION REGARDING THE MANNER OF ENFORCEMENT OF THE ORIGINAL JUDG-
7 MENT.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. That Section 10-1111, Idaho Code, be, and the same is hereby
10 amended to read as follows:

11 10-1111. ~~RENEWAL OF ORDERS RENEWING JUDGMENT~~ -- LIEN. (1) Unless the
12 judgment has been satisfied, at any time prior to the expiration of the lien
13 created by section 10-1110, Idaho Code, or any renewal thereof, the court
14 that entered the judgment, other than a judgment for child support, may,
15 upon motion, renew such judgment by entry of an order renewing judgment.
16 The ~~renewed order renewing judgment~~ may be recorded in the same manner as
17 the original judgment, and the lien established or continued thereby shall
18 continue for ten (10) years from the date of the ~~renewed order renewing judg-~~
19 ~~ment.~~ Entry of an order renewing judgment maintains both the date of the
20 original judgment and the priority of collection thereof, and it begins anew
21 the time limitation for an action upon a judgment set forth in section 5-215,
22 Idaho Code.

23 (2) Unless the judgment has been satisfied, and prior to the expiration
24 of the lien created in section 10-1110, Idaho Code, or any renewal thereof,
25 a court that has entered a judgment for child support may, upon motion, renew
26 such judgment by entry of an order renewing judgment. The ~~renewed entry of an~~
27 ~~order renewing judgment may be enforced in~~ shall not affect the same manner
28 as of enforcement of the original judgment, and the lien established or con-
29 tinued thereby shall continue for ten (10) years from the date of the ~~renewed~~
30 ~~order renewing judgment.~~ Entry of an order renewing judgment maintains both
31 the date of the original judgment and the priority of collection thereof, and
32 it begins anew the time limitation for an action upon a judgment set forth in
33 section 5-215, Idaho Code.
