Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. That Chapter 3, Title 40, Idaho Code, be, and the same is hereby amended by the addition thereto of a $\underline{\text{NEW SECTION}}$, to be known and designated as Section 40-310A, Idaho Code, and to read as follows:

- 40-310A. POWERS AND DUTIES -- ACCESS CONTROL -- RULEMAKING FACTORS. (1) A departmental rule or regulation that controls a right of access to a state highway affecting an area within a city shall ensure a balance between property access and the functional integrity of the road system and shall include:
 - (a) The authority of district engineers to grant variances for access spacing based on input from local officials;
 - (b) The weighing of economic opportunity considerations by district engineers, including information provided by property owners and local officials. Pursuant to such authority, a district engineer evaluating a request for a variance within the limits of a city shall be authorized to approve a decrease in minimum access spacing of up to fifty percent (50%) without the requirement of a traffic study;
 - (c) The authority of local officials to influence access variance decisions, including within the appeals process;
 - (d) An access control classification system as provided in subsection
 - (2) of this section; and
 - (e) If a traffic study is required:
 - (i) Any necessary components of such study shall be supplied to the owner prior to commissioning such study; and
 - (ii) The results of such traffic study shall be accepted by the department if the study is conducted by a professional engineer, as defined in section 54-1202, Idaho Code, and the results have been sealed, signed, and dated by such engineer pursuant to section 54-1215, Idaho Code.
- (2) By January 1, 2021, the department shall develop an access control classification system in cooperation with cities to include assignment of a road segment to a specific access category pursuant to the following criteria:
 - (a) Local land use plans and zoning, as set forth in comprehensive plans;
 - (b) The current functional classification as well as potential future functional classification of each road on the state highway system;
 - (c) Existing and projected traffic volumes;

- 1 (d) Existing and projected state and local transportation plans and 2 needs;
- 3 (e) Drainage requirements;
- 4 (f) The character of lands adjoining the highway;
- 5 (g) The type and volume of traffic requiring access;
- 6 (h) Other operational aspects of access;
 - (i) The availability of reasonable access to a state highway; and
- (j) The cumulative effect of existing and projected connections on the state highway system's ability to provide for the safe and efficient movement of people and goods within the state.
