AN ACT

1 RELATING TO APPROPRIATIONS; APPROPRIATING ADDITIONAL MONEYS TO THE EXECU-  
2 TIVE OFFICE OF THE GOVERNOR FOR THE ADMINISTRATION - GOVERNOR'S OFFICE  
3 PROGRAM FOR FISCAL YEAR 2019; APPROPRIATING ADDITIONAL MONEYS TO THE  
4 LIEUTENANT GOVERNOR FOR FISCAL YEAR 2019; APPROPRIATING ADDITIONAL  
5 MONEYS TO THE SECRETARY OF STATE FOR THE SECRETARY OF STATE PROGRAM  
6 FOR FISCAL YEAR 2019; APPROPRIATING ADDITIONAL MONEYS TO THE STATE  
7 CONTROLLER FOR THE ADMINISTRATION PROGRAM FOR FISCAL YEAR 2019; APPRO-  
8 PRIATING ADDITIONAL MONEYS TO THE STATE TREASURER FOR FISCAL YEAR 2019;  
9 APPROPRIATING ADDITIONAL MONEYS TO THE SUPERINTENDENT OF PUBLIC IN-  
10 STRUCTION FOR THE STATE DEPARTMENT OF EDUCATION PROGRAM FOR FISCAL YEAR  
11 2019; AND APPROPRIATING ADDITIONAL MONEYS TO THE ATTORNEY GENERAL FOR  
12 THE STATE LEGAL SERVICES PROGRAM FOR FISCAL YEAR 2019.

14 Be It Enacted by the Legislature of the State of Idaho:

15 SECTION 1. In addition to any other appropriation provided by law,  
16 there is hereby appropriated to the Executive Office of the Governor for the  
17 Administration - Governor's Office Program \$7,300 from the General Fund to  
18 be expended for personnel costs for the period July 1, 2018, through June 30,  
19 2019, for the purpose of the Governor's salary.

20 SECTION 2. In addition to any other appropriation provided by law,  
21 there is hereby appropriated to the Lieutenant Governor \$2,500 from the  
22 General Fund to be expended for personnel costs for the period July 1, 2018,  
23 through June 30, 2019, for the purpose of the Lieutenant Governor's salary.

24 SECTION 3. In addition to any other appropriation provided by law,  
25 there is hereby appropriated to the Secretary of State for the Secretary of  
26 State Program \$6,200 from the General Fund to be expended for personnel costs  
27 for the period July 1, 2018, through June 30, 2019, for the purpose of the  
28 Secretary of State's salary.

29 SECTION 4. In addition to any other appropriation provided by law,  
30 there is hereby appropriated to the State Controller for the Administration  
31 Program \$6,200 from the General Fund to be expended for personnel costs for  
32 the period July 1, 2018, through June 30, 2019, for the purpose of the State  
33 Controller's salary.

34 SECTION 5. In addition to any other appropriation provided by law,  
35 there is hereby appropriated to the State Treasurer \$6,200 from the General  
36 Fund to be expended for personnel costs for the period July 1, 2018, through  
37 June 30, 2019, for the purpose of the State Treasurer's salary.

1           SECTION 6. In addition to any other appropriation provided by law,  
2 there is hereby appropriated to the Superintendent of Public Instruction for  
3 the State Department of Education Program \$6,200 from the General Fund to be  
4 expended for personnel costs for the period July 1, 2018, through June 30,  
5 2019, for the purpose of the Superintendent of Public Instruction's salary.

6           SECTION 7. In addition to any other appropriation provided by law,  
7 there is hereby appropriated to the Attorney General for the State Legal  
8 Services Program \$6,000 from the General Fund to be expended for personnel  
9 costs for the period July 1, 2018, through June 30, 2019, for the purpose of  
10 the Attorney General's salary.
