SENATE BILL NO. 1385

AN ACT

RELATING TO THE APPROPRIATION TO THE IDAHO COMMISSION FOR LIBRARIES; APPROPRIATING ADDITIONAL MONEYS TO THE IDAHO COMMISSION FOR LIBRARIES FOR FISCAL YEAR 2025; PROVIDING REAPPROPRIATION AUTHORITY FOR LIBRARY PROJECTS; PROVIDING REAPPROPRIATION AUTHORITY FOR DIGITAL ACCESS CAPACITY; REAFFIRMING STATUTORY COMPLIANCE REGARDING TELEHEALTH FACILITIES; AND DECLARING AN EMERGENCY AND PROVIDING AN EFFECTIVE DATE.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. In addition to any other appropriation provided by law, there is hereby appropriated to the Idaho Commission for Libraries the following amounts to be expended according to the designated expense classes from the listed funds for the period July 1, 2024, through June 30, 2025:

SECTION 2. REAPPROPRIATION AUTHORITY FOR LIBRARY PROJECTS. There is hereby reappropriated to the Idaho Commission for Libraries any unexpended and unencumbered balance appropriated or reappropriated to the Idaho Commission for Libraries from the ARPA Capital Projects Fund for fiscal year 2024, in an amount not to exceed \$1,900,000 from the ARPA Capital Projects Fund, to be used for nonrecurring expenditures related to library capital projects for the period July 1, 2024, through June 30, 2025. The Office of the State Controller shall confirm the reappropriation amount by fund, expense class, and program, with the Legislative Services Office Budget and Policy Analysis Division prior to processing the reappropriation authorized herein.

SECTION 3. REAPPROPRIATION AUTHORITY FOR DIGITAL ACCESS CAPACITY. There is hereby reappropriated to the Idaho Commission for Libraries any unexpended and unencumbered balance appropriated or reappropriated to the Idaho Commission for Libraries from the Federal Grant Fund for fiscal year 2024, in an amount not to exceed \$1,750,000 from the Federal Grant Fund, to

1 be used for nonrecurring expenditures related to digital access capacity  
2 for the period July 1, 2024, through June 30, 2025. The Office of the State  
3 Controller shall confirm the reappropriation amount by fund, expense class,  
4 and program, with the Legislative Services Office Budget and Policy Analysis  
5 Division prior to processing the reappropriation authorized herein.

6 SECTION 4. TELEHEALTH FACILITIES. Of the moneys reappropriated in Sec-  
7 tion 2 of this act from the ARPA Capital Projects Fund for library capital  
8 projects, no funds shall be expended for facility and technology projects  
9 that do not comply with Sections 18-608 and 18-617, Idaho Code.

10 SECTION 5. An emergency existing therefor, which emergency is hereby  
11 declared to exist, this act shall be in full force and effect on and after  
12 July 1, 2024.
