SENATE BILL NO. 1395, As Amended in the House

AN ACT

1 RELATING TO SALARIES OF STATE ELECTIVE OFFICERS; AMENDING SECTION 59-501,
2 IDAHO CODE, TO REVISE THE SALARIES OF STATE ELECTIVE OFFICERS EXCEPT
3 FOR THE ATTORNEY GENERAL FOR THE PERIOD FROM THE FIRST MONDAY IN JANUARY
4 2015 UNTIL THE FIRST MONDAY IN JANUARY 2019, TO PROVIDE FOR THE SALARY
5 OF THE ATTORNEY GENERAL DURING HIS TERM OF OFFICE AND TO MAKE TECHNICAL
6 CORRECTIONS.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. That Section 59-501, Idaho Code, be, and the same is hereby
10 amended to read as follows:

11 59-501. SALARIES OF STATE ELECTIVE OFFICERS -- REGULAR PAYMENT --
12 TRAVELING EXPENSES -- FEES PROPERTY OF STATE. (1) The governor, lieutenant
13 governor, secretary of state, state controller, state treasurer, attorney
14 general and superintendent of public instruction shall, during their con-
15 tinuance in office, receive for their services compensation as follows:

16 Commencing on the first Monday in January 201~~4~~5, until the first Monday
17 in January 201~~2~~6:

18 Governor, ~~\$110,734~~120,785 per annum;

19 Lieutenant governor, ~~\$29,184~~42,275 per annum;

20 Secretary of state, ~~\$90,006~~102,667 per annum;

21 State controller, ~~\$90,006~~102,667 per annum; said compensation to be au-
22 dited by the legislative council;

23 ~~Attorney general, \$99,825 per annum;~~

24 State treasurer, ~~\$90,006~~102,667 per annum; and

25 State superintendent of public instruction, ~~\$90,006~~102,667 per annum.

26 (2) The governor, lieutenant governor, secretary of state, state con-
27 troller, state treasurer, ~~attorney general~~ and superintendent of public in-
28 struction shall, during their continuance in office, receive for their ser-
29 vices compensation as follows:

30 Commencing on the first Monday in January 201~~2~~6, until the first Monday
31 in January 201~~3~~7:

32 Governor, ~~\$115,348~~122,597 per annum;

33 Lieutenant governor, ~~\$30,400~~42,909 per annum;

34 Secretary of state, ~~\$93,756~~104,207 per annum;

35 State controller, ~~\$93,756~~104,207 per annum; said compensation to be au-
36 dited by the legislative council;

37 ~~Attorney general, \$103,984 per annum;~~

38 State treasurer, ~~\$93,756~~104,207 per annum; and

39 State superintendent of public instruction, ~~\$93,756~~104,207 per annum.

40 (3) Commencing on the first Monday in January 201~~3~~7, until the first
41 Monday in January 201~~4~~8, the governor shall receive for his services compen-
42 sation of ~~\$117,000~~124,436 per annum; and each officer named in subsection

1 (2) of this section, except for the governor and attorney general, shall re-
2 ceive the following compensation for their services:

3 Lieutenant governor, thirty-five percent (30~~5~~%) of the governor's com-
4 pensation as provided for in this subsection, per annum;

5 Secretary of state, eighty-five percent (85%) of the governor's compen-
6 sation as provided for in this subsection, per annum;

7 State controller, eighty-five percent (85%) of the governor's compen-
8 sation as provided for in this subsection, per annum; said compensation to be
9 audited by the legislative council;

10 ~~Attorney general, ninety percent (90%) of the governor's compensation~~
11 ~~as provided for in this subsection, per annum;~~

12 State treasurer, eighty-five percent (85%) of the governor's compensa-
13 tion as provided for in this subsection, per annum; and

14 State superintendent of public instruction, eighty-five percent (85%)
15 of the governor's compensation as provided for in this subsection, per an-
16 num.

17 (4) Commencing on the first Monday in January 2014~~8~~⁹, until the first
18 Monday in January 2015~~9~~⁹, the governor shall receive for his services compen-
19 sation of \$~~119,000~~^{126,302} per annum; and each officer named in subsection
20 (3) of this section, except for the governor and attorney general, shall re-
21 ceive the following compensation for their services:

22 Lieutenant governor, thirty-five percent (30~~5~~%) of the governor's com-
23 pensation as provided for in this subsection, per annum;

24 Secretary of state, eighty-five percent (85%) of the governor's compen-
25 sation as provided for in this subsection, per annum;

26 State controller, eighty-five percent (85%) of the governor's compen-
27 sation as provided for in this subsection, per annum; said compensation to be
28 audited by the legislative council;

29 ~~Attorney general, ninety percent (90%) of the governor's compensation~~
30 ~~as provided for in this subsection, per annum;~~

31 State treasurer, eighty-five percent (85%) of the governor's compensa-
32 tion as provided for in this subsection, per annum; and

33 State superintendent of public instruction, eighty-five percent (85%)
34 of the governor's compensation as provided for in this subsection, per an-
35 num.

36 (5) Prior to the start of the next term of office for the attorney gen-
37 eral, the attorney general's salary shall be increased to match that of a
38 district judge as provided in section 59-502, Idaho Code, on December 31 of
39 the last year of the attorney general's term of office. Such increase shall
40 take effect on the first Monday in January of the attorney general's term of
41 office.

42 (6) Such compensation shall be paid on regular pay periods as due out of
43 the state treasury, and shall be in full for all services by said officers re-
44 spectively rendered in any official capacity or employment whatever during
45 their respective terms of office; but no increase in the rate of compensation
46 shall be made during the terms of such officers; provided, however, that the
47 actual and necessary expenses of the governor, lieutenant governor, secre-
48 tary of state, attorney general, state controller, state treasurer, and su-
49 perintendent of public instruction while traveling within the state, or be-
50 tween points within the state, in the performance of official duties, shall

1 be allowed and paid by the state; not however, exceeding such sum as shall be
2 appropriated for such purpose.

3 (~~67~~) Actual and necessary subsistence expenses of the governor while
4 traveling in connection with the performance of official duties are hereby
5 expressly exempted from the provisions of sections 67-2007 and 67-2008,
6 Idaho Code. (Standard Travel Pay and Allowance Act of 1949).

7 (~~78~~) No officer named in this section shall receive, for the perfor-
8 mance of any official duty any fee for his own use, but all fees fixed by law
9 for the performance by either of them, of any official duty, shall be col-
10 lected in advance and deposited with the state treasurer to the credit of the
11 state.
