SENATE BILL NO. 1399

AN ACT

1 RELATING TO THE APPROPRIATION TO IDAHO PUBLIC TELEVISION; APPROPRIATING AD-
2 DITIONAL MONEYS TO IDAHO PUBLIC TELEVISION FOR FISCAL YEAR 2025; PRO-
3 VIDING REAPPROPRIATION AUTHORITY FOR THE IDAHO MILLENNIUM INCOME FUND;
4 PROVIDING REAPPROPRIATION AUTHORITY FOR THE FEDERAL GRANT FUND; APPRO-
5 PRIATING ADDITIONAL MONEYS TO IDAHO PUBLIC TELEVISION FOR FISCAL YEAR
6 2024; AND DECLARING AN EMERGENCY AND PROVIDING EFFECT DATES.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. In addition to any other appropriation provided by law,
10 there is hereby appropriated to Idaho Public Television the following
11 amounts to be expended according to the designated expense classes from the
12 General Fund for the period July 1, 2024, through June 30, 2025:

14 Personnel Costs	\$26,100
15 Capital Outlay	<u>42,400</u>
16 TOTAL	\$68,500

17 SECTION 2. REAPPROPRIATION AUTHORITY - IDAHO MILLENNIUM INCOME FUND.
18 There is hereby reappropriated to Idaho Public Television any unexpended and
19 unencumbered balances appropriated or reappropriated to Idaho Public Tele-
20 vision from the Idaho Millennium Income Fund for fiscal year 2024 to be used
21 for nonrecurring expenditures for the period July 1, 2024, through June 30,
22 2025. The Office of the State Controller shall confirm the reappropriation
23 amount, by fund, expense class, and program, with the Legislative Services
24 Office prior to processing the reappropriation authorized herein.

25 SECTION 3. REAPPROPRIATION AUTHORITY - FEDERAL GRANT FUND. There is
26 hereby reappropriated to Idaho Public Television any unexpended and unen-
27 cumbered balances appropriated to Idaho Public Television from the Federal
28 Grant Fund for fiscal year 2024 to be used for nonrecurring expenditures for
29 the period July 1, 2024, through June 30, 2025. The Office of the State Con-
30 troller shall confirm the reappropriation amount, by fund, expense class,
31 and program, with the Legislative Services Office prior to processing the
32 reappropriation authorized herein.

33 SECTION 4. In addition to the appropriation made in Section 1, Chap-
34 ter 115, Laws of 2023, and any other appropriation provided by law, there is
35 hereby appropriated to Idaho Public Television the following amounts to be
36 expended according to the designated expense classes from the Federal Grant
37 Fund for the period July 1, 2023, through June 30, 2024:

5 SECTION 5. An emergency existing therefor, which emergency is hereby
6 declared to exist, Section 4 of this act shall be in full force and effect on
7 and after passage and approval, and Sections 1 through 3 of this act shall be
8 in full force and effect on and after July 1, 2024.
