SENATE BILL NO. 1404

BY FINANCE COMMITTEE

AN ACT

REDUCING THE APPROPRIATION TO THE ATTORNEY GENERAL FOR FISCAL YEAR 2010; APPROPRIATING MONEYS TO THE ATTORNEY GENERAL FOR FISCAL YEAR 2011; LIMITING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT POSITIONS; EXEMPTING THE ATTORNEY GENERAL FROM CERTAIN APPROPRIATION TRANSFER LIMITATIONS FOR FISCAL YEAR 2011; AND DECLARING AN EMERGENCY.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. Notwithstanding any other provision of law to the contrary, the appropriation made in Section 1, Chapter 209, Laws of 2009, is hereby reduced by the following amounts for the designated programs, according to the designated expense classes from the listed fund for the period July 1, 2009, through June 30, 2010:

10 SECTION 3. In accordance with Section 67-3519, Idaho Code, the Attorney
11 General is authorized no more than two hundred seven and fifteen-hundredths
12 (207.15) full-time equivalent positions at any point during the period
13 July 1, 2010, through June 30, 2011, for the programs specified in Section
14 2 of this act, unless specifically authorized by the Governor. The Joint
15 Finance-Appropriations Committee will be notified promptly of any increased
16 positions so authorized.

17 SECTION 4. To provide maximum flexibility in dealing with reduced ap-
18 propriations for Fiscal Year 2011, the Attorney General is hereby exempted
19 from the provisions of Section 67-3511, Idaho Code, for all moneys appropri-
20 ated to it for the period July 1, 2010, through June 30, 2011. Legislative
21 appropriations shall not be transferred from one fund to another fund, how-
22 ever, unless expressly approved by the Legislature.

23 SECTION 5. An emergency existing therefor, which emergency is hereby
24 declared to exist, Section 1 of this act shall be in full force and effect on
25 and after passage and approval.
