AN ACT

APPROPRIATING MONEYS TO THE OFFICE OF THE STATE BOARD OF EDUCATION FOR FISCAL
 YEAR 2015; LIMITING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT POSI TIONS; PROVIDING GUIDANCE FOR EMPLOYEE COMPENSATION; PROVIDING FEDERAL
 FUND REAPPROPRIATION; AND PROVIDING LEGISLATIVE INTENT FOR SUPPORT OF
 SPECIAL COMMITTEES.

7 Be It Enacted by the Legislature of the State of Idaho:

8 SECTION 1. There is hereby appropriated to the Office of the State Board 9 of Education, the following amounts to be expended according to the desig-10 nated programs and expense classes, from the listed funds for the period July 11 1, 2014, through June 30, 2015:

9 SECTION 2. FTP AUTHORIZATION. In accordance with Section 67-3519, 10 Idaho Code, the Office of the State Board of Education is authorized no more 11 than twenty-three and seventy-five hundredths (23.75) full-time equivalent 12 positions at any point during the period July 1, 2014, through June 30, 2015, 13 unless specifically authorized by the Governor. The Joint Finance-Appro-14 priations Committee will be notified promptly of any increased positions so 15 authorized.

SECTION 3. EMPLOYEE COMPENSATION. It is the intent of the Legislature, working cooperatively with the Governor's Office, the Division of Human Resources, and the Division of Financial Management, to progress toward the goal of funding a competitive salary and benefit package that will attract qualified applicants, retain employees committed to public service excellence, motivate employees to maintain high standards of productivity, and reward employees for outstanding performance by:

- Adjusting the compensation schedule upwards by 1% to move the salary
   structure toward market; and
- 2) Continuing the job classifications that are currently on payline
   26 exception to address specific recruitment or retention issues; and

Funding an ongoing 1% salary increase for state employees, and funding
 the equivalent of a one-time 1% bonus for state employees, based upon
 employee merit, with flexibility in distribution as determined by
 the agency directors.

The Legislature also finds that investing in state employee compensa-31 tion should remain a high priority even in tough economic times, and there-32 fore strongly encourages agency directors, institution executives and the 33 Division of Financial Management to approve the use of salary savings to pro-34 vide either one-time or ongoing merit increases for deserving employees and 35 also to target employees who are below policy compensation. Such salary sav-36 37 ings could result from turnover and attrition, or be the result of innovation and reorganization efforts that create savings. Such savings should be 38 reinvested in employees. Agencies are cautioned to use one-time funding for 39 one-time payments and ongoing funding for permanent pay increases. 40

41 SECTION 4. FEDERAL FUND REAPPROPRIATION AUTHORITY. There is hereby 42 reappropriated to the Office of the State Board of Education any unexpended and unencumbered balances of moneys categorized as federal funds as appropriated for fiscal year 2014, to be used for nonrecurring expenditures, for
the period July 1, 2014, through June 30, 2015.

SECTION 5. LEGISLATIVE INTENT. It is the intent of the Legislature 4 that up to \$30,000 of General Fund moneys appropriated in this act may be 5 expended during fiscal year 2015 in support of special committees, under 6 the oversight of the State Board of Education, to study K-12 public school 7 structure and funding. The committees could address career ladder com-8 pensation, tiered licensure, accountability, autonomy, mastery learning, 9 10 average daily attendance or cooperative service agencies, but would not be limited to those topics. The State Board of Education shall report on the use 11 of funds to the Idaho Legislature's Joint Finance-Appropriations Committee, 12 Senate Education Committee and House Education Committee by no later than 13 January 1, 2015. 14
