AN ACT

1 APPROPRIATING ADDITIONAL MONEYS TO THE EXECUTIVE OFFICE OF THE GOVERNOR FOR
2 FISCAL YEAR 2015; APPROPRIATING ADDITIONAL MONEYS TO THE OFFICE OF THE
3 LIEUTENANT GOVERNOR FOR FISCAL YEAR 2015; APPROPRIATING ADDITIONAL
4 MONEYS TO THE SECRETARY OF STATE FOR FISCAL YEAR 2015; APPROPRIATING
5 ADDITIONAL MONEYS TO THE STATE CONTROLLER FOR FISCAL YEAR 2015; AP-
6 PROPRIATING ADDITIONAL MONEYS TO THE ATTORNEY GENERAL FOR FISCAL YEAR
7 2015; APPROPRIATING ADDITIONAL MONEYS TO THE STATE TREASURER FOR FISCAL
8 YEAR 2015; AND APPROPRIATING ADDITIONAL MONEYS TO THE SUPERINTENDENT OF
9 PUBLIC INSTRUCTION FOR FISCAL YEAR 2015.

11 Be It Enacted by the Legislature of the State of Idaho:

12 SECTION 1. In addition to the appropriation made in Section 1 of House
13 Bill No. 626, as enacted by the Second Regular Session of the Sixty-second
14 Idaho Legislature, there is hereby appropriated to the Executive Office of
15 the Governor \$1,800 from the General Fund to be expended for personnel costs
16 for the period July 1, 2014, through June 30, 2015.

17 SECTION 2. In addition to the appropriation made in Section 1 of Senate
18 Bill No. 1386, as enacted by the Second Regular Session of the Sixty-second
19 Idaho Legislature, there is hereby appropriated to the Office of the Lieu-
20 tenant Governor \$4,200 from the General Fund to be expended for personnel
21 costs for the period July 1, 2014, through June 30, 2015.

22 SECTION 3. In addition to the appropriation made in Section 1 of Senate
23 Bill No. 1388, as enacted by the Second Regular Session of the Sixty-second
24 Idaho Legislature, there is hereby appropriated to the Secretary of State
25 \$1,500 from the General Fund to be expended for personnel costs for the pe-
26 riod July 1, 2014, through June 30, 2015.

27 SECTION 4. In addition to the appropriation made in Section 1 of House
28 Bill No. 609, as enacted by the Second Regular Session of the Sixty-sec-
29 ond Idaho Legislature, there is hereby appropriated to the State Controller
30 \$1,500 from the General Fund to be expended for personnel costs for the pe-
31 riod July 1, 2014, through June 30, 2015.

32 SECTION 5. In addition to the appropriation made in Section 1 of Senate
33 Bill No. 1391, as enacted by the Second Regular Session of the Sixty-sec-
34 ond Idaho Legislature, there is hereby appropriated to the Attorney General
35 \$10,200 from the General Fund to be expended for personnel costs for the pe-
36 riod July 1, 2014, through June 30, 2015.

37 SECTION 6. In addition to the appropriation made in Section 1 of Senate
38 Bill No. 1409, as enacted by the Second Regular Session of the Sixty-sec-

1 ond Idaho Legislature, there is hereby appropriated to the State Treasurer
2 \$1,500 from the General Fund to be expended for personnel costs for the pe-
3 riod July 1, 2014, through June 30, 2015.

4 SECTION 7. In addition to the appropriation made in Section 1 of Senate
5 Bill No. 1419, as enacted by the Second Regular Session of the Sixty-sec-
6 ond Idaho Legislature, there is hereby appropriated to the Superintendent of
7 Public Instruction \$1,500 from the General Fund to be expended for personnel
8 costs for the period July 1, 2014, through June 30, 2015.
