SENATE BILL NO. 1440

2 REDUCING THE APPROPRIATION TO THE DEPARTMENT OF LABOR FOR FISCAL YEAR 2010;
3 APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF LABOR FOR FISCAL
4 YEAR 2010; APPROPRIATING MONEYS FOR ADMINISTRATION OF THE UNEMPLOY-
5 MENT INSURANCE AND EMPLOYMENT SERVICES PROGRAM FOR FISCAL YEAR 2011;
6 APPROPRIATING MONEYS TO THE DEPARTMENT OF LABOR FOR FISCAL YEAR 2011;
7 LIMITING THE NUMBER OF FULL-TIME EQUIVALENT POSITIONS; AND DECLARING AN
8 EMERGENCY.

9 Be It Enacted by the Legislature of the State of Idaho:

10 SECTION 1. Notwithstanding any other provision of law to the contrary,
11 the appropriation made in Section 3, Chapter 288, Laws of 2009, to the De-
12 partment of Labor is hereby reduced by the following amount for the desig-
13 nated program according to the designated expense classes from the listed
14 fund for the period July 1, 2009, through June 30, 2010:

 2 to the Department of Labor of the State of Idaho, pursuant to Section 903 of
 3 the Federal Social Security Act, as amended, \$2,304,400 for the payment of
 4 expenses incurred for the administration of the Unemployment Insurance and
 5 Employment Services Program. This appropriation is authorized and subject
 6 to the limitations of Section 72-1346, Idaho Code. This appropriation is for
 7 the period July 1, 2010, through June 30, 2011.

9 SECTION 5. In accordance with Section 67-3519, Idaho Code, the Depart-
10 ment of Labor is authorized no more than twenty-five (25) full-time equiva-
11 lent positions at any point during the period July 1, 2010, through June 30,
12 2011, for the programs specified in Section 4 of this act, unless specifi-
13 cally authorized by the Governor. The Joint Finance-Appropriations Commit-
14 tee will be notified promptly of any increased positions so authorized.

15 SECTION 6. An emergency existing therefor, which emergency is hereby
16 declared to exist, Sections 1 and 2 of this act shall be in full force and ef-
17 fect on and after passage and approval.
