A CONCURRENT RESOLUTION

- 2 STATING LEGISLATIVE FINDINGS AND APPROVING AND EXTENDING TEMPORARY RULES
 3 REVIEWED BY THE LEGISLATURE, WITH STATED EXCEPTIONS.
- 4 Be It Resolved by the Legislature of the State of Idaho:

5 WHEREAS, the Legislature by statute must approve temporary rules by 6 adoption of a concurrent resolution approving the rule if the temporary rule 7 is to remain in effect beyond the end of the current legislative session; and 8 WHEREAS, the expiration of temporary rules would occasion additional 9 expense to state agencies in readopting and republishing temporary rules

10 needed to conduct state business; and

11 WHEREAS, the Legislature finds that it is in the public interest to 12 adopt this resolution.

13 NOW, THEREFORE, BE IT RESOLVED by the members of the Second Regular Ses-14 sion of the Sixty-first Idaho Legislature, the Senate and the House of Representatives concurring therein, that all temporary rules adopted by state 15 agencies pursuant to the Administrative Procedure Act and submitted to the 16 Legislature at the Legislature's request through the Office of Rules Coor-17 dinator for review during the 2012 legislative session, and all temporary 18 rules previously approved and extended by concurrent resolution adopted in 19 a prior regular session of the Idaho Legislature, be, and the same are ap-20 proved, with the exception of the following enumerated temporary rules: 21

IDAPA 16.03.09, Department of Health and Welfare, Medicaid Ba sic Plan Benefits, adopted as a temporary rule under Docket Number
 16-0309-1201, the entire rulemaking docket; and

IDAPA 26.01.36, Department of Parks and Recreation, Rules Gov erning the Winter Recreational Parking Permit Program, adopted as
 a temporary rule under Docket Number 26-0136-1101, the entire rule making docket.

29 BE IT FURTHER RESOLVED that a temporary rule or partial temporary rule approved by this concurrent resolution shall remain in effect until it ex-30 pires by its own terms or by operation of law or until it is replaced by a 31 final rule, but in no event shall a temporary rule remain in effect beyond 32 the conclusion of the First Regular Session of the Sixty-second Idaho Legis-33 34 lature unless it is further extended by adoption of a concurrent resolution by both houses of the Legislature. Temporary rules or sections of temporary 35 rules which are excepted from approval hereunder or which were not submitted 36 37 to the Legislature for review during the 2012 legislative session shall expire by operation of statute upon adjournment of the Second Regular Session 38 of the Sixty-first Idaho Legislature, unless approved by adoption of a sepa-39 rate concurrent resolution by both houses of the Legislature. 40
