Section 10. The sum of \$112,200, or so much thereof as may 2 3 be necessary and remains unexpended at the close of business on June 30, 2023, from appropriations heretofore made for such 4 5 purpose in Article 138, Section 10 of Public Act 102-0698 is reappropriated from the State Coronavirus Urgent Remediation 6 Emergency Fund to the Department of Children and Family 7 8 Services for a grant to the Court Appointed Special Advocates 9 of Cook County to be used to advocate for the timely placement 10 of children in permanent, safe, and stable homes, for purposes permitted by Section 9901 of the American Rescue Plan Act of 11 12 2021 and related federal guidance.

13 Section 999. Effective date. This Act takes effect July 1,14 2023.
