Makes appropriations for the ordinary and contingent expenses of the Department of Employment Security for the fiscal year beginning July 1, 2023, as follows:

A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. In addition to any other sums appropriated, the  
6 sum of \$405,122,800 or so much thereof as may be necessary, is  
7 appropriated from the Title III Social Security and Employment  
8 Fund to the Department of Employment Security for operational  
9 expenses, awards, grants, and permanent improvements for the  
10 fiscal year ending June 30, 2024, including prior year costs.

11 Section 10. The sum of \$60,000,000 or so much thereof as  
12 may be necessary, is appropriated from the General Revenue Fund  
13 to the Department of Employment Security for deposit into the  
14 Title III Social Security and Employment Fund for operational  
15 expenses for the fiscal year ending June 30, 2024.

17 Section 15. The following named sums, or so much thereof  
18 as may be necessary, are appropriated to the Department of  
19 Employment Security:

5 Section 25. The following named amounts, or so much thereof  
 6 as may be necessary, are appropriated to the Department of  
 7 Employment Security for unemployment compensation benefits to  
 8 former state employees as follows:

9 TRUST FUND UNIT  
 10 Grants-In-Aid  
 11 Payable from the Road Fund:  
 12 For benefits paid on the basis of wages  
 13 paid for insured work for the Department  
 14 of Transportation .....4,000,000  
 15 Payable from Title III Social Security  
 16 and Employment Fund: .....1,734,300  
 17 Payable from the General Revenue Fund: .....21,000,000  
 18 Total \$26,734,300

19 Section 30. The sum of \$200,000, or so much thereof as may  
 20 be necessary, is appropriated from the General Revenue Fund to  
 21 the Department of Employment Security for all ordinary and  
 22 contingent expenses related to the implementation of Automatic  
 23 Voter Registration.

1           Section 35. The amount of \$10,000,000, or so much thereof  
2 as may be necessary, is appropriated from the Unemployment  
3 Compensation Special Administration Fund to the Department of  
4 Employment Security for the payment of interest on advances  
5 made to the Unemployment Trust Fund as required by Title XII  
6 of the Social Security Act.

7  
8           Section 40. The amount of \$8,000,000, or so much thereof  
9 as may be necessary, is appropriated from the General Revenue  
10 Fund to the Department of Employment Security for deposit into  
11 the Title III Social Security and Employment Fund for the  
12 payment of interest on advances made to the Unemployment Trust  
13 Fund as required by Title XII of the Social Security Act.

14  
15           Section 45. The amount of \$75,000,000, or so much thereof  
16 as may be necessary, is appropriated from the General Revenue  
17 Fund to the Department of Employment Security for the return  
18 of federal funds to the Federal Emergency Management Agency in  
19 accordance with 44 C.F.R. § 206.120(f).

20  
21           Section 50. The amount of \$700,000, or so much thereof as  
22 may be necessary, is appropriated from the General Revenue Fund  
23 to the Department of Employment Security for data analysis and  
24 administrative expenses associated with the Homelessness

1 Prevention administrative data pilot addressing homelessness  
2 prevention strategies.

4 Section 55. The amount of \$155,000, or so much thereof as  
5 may be necessary, is appropriated from the General Revenue Fund  
6 to the Department of Employment Security to implement  
7 diversity, equity and inclusion initiatives.

8 Section 99. Effective date. This Act takes effect July 1,  
9 2023.
