13 Department's response to natural disasters, emergencies and
14 acts of terrorism that receive Presidential and/or State
15 Disaster Declaration status. These costs would include, but
16 not be limited to, the Department's fuel costs, cost of
17 materials and cost of equipment rentals. This appropriation
18 is in addition to the Department's other appropriations for
19 District and Central Office operations.

20 Section 75. The sum of \$100,000, or so much thereof as may
21 be necessary, is appropriated from the Road Fund to the
22 Department of Transportation for costs associated with the

1 Technology Transfer Center, including the purchase of
2 equipment, media initiatives, and training, provided that such
3 expenditures do not exceed funds to be made available by the
4 federal government for this purpose.

5 Section 80. The sum of \$5,000,000, or so much thereof as
6 may be necessary, is appropriated from the Road Fund to the
7 Department of Transportation for costs associated with highway
8 safety media campaigns, provided such amounts do not exceed
9 funds to be made available from the federal government.

10 Section 85. The sum of \$10,300,000, or so much thereof as
11 may be necessary, is appropriated from the Road Fund to the
12 Department of Transportation for the IDOT ITS Program.

16 agreements with the Illinois Department of State Police to

2 as may be necessary, is appropriated from the Public
3 Transportation Fund to the Department of Transportation for the
4 purpose stated in Section 4.09 of the "Regional Transportation
5 Authority Act", as amended.

6 Section 235. The sum of \$21,000,000, or so much thereof
7 as may be necessary, is appropriated from the Public
8 Transportation Fund to the Department of Transportation for
9 making a grant to the Regional Transportation Authority for
10 Additional State Assistance to be used for its purposes as
11 provided in the "Regional Transportation Authority Act", but
12 in no event shall this amount exceed the amount provided for
13 in Sections 4.09 (c) and 4.09 (d) with respect to Strategic
14 Capital Improvement bonds issued by the Regional Transportation
15 Authority pursuant to the Regional Transportation Authority Act
16 as amended in 1989.

17 Section 240. The sum of \$93,000,000, or so much thereof
18 as may be necessary, is appropriated from the Public
19 Transportation Fund to the Department of Transportation for
20 making a grant to the Regional Transportation Authority for
21 Additional Financial Assistance to be used for its purposes as
22 provided in the "Regional Transportation Authority Act", but
23 in no event shall this amount exceed the amount provided for

1 in Sections 4.09 (c-5) and 4.09 (d) with respect to Strategic
2 Capital Improvement bonds issued by the Regional Transportation
3 Authority pursuant to the Regional Transportation Authority Act
4 as amended in 1999.

5 Section 245. The sum of \$19,063,500, or so much thereof
6 as may be necessary, is appropriated from the Road Fund to the
7 Department of Transportation for grants to the Regional
8 Transportation Authority intended to reimburse the Service
9 Boards for providing reduced fares on mass transportation
10 services for students, handicapped persons, and the elderly,
11 to be allocated proportionally among the Service Boards based
12 upon actual costs incurred by each Service Board for such
13 reduced fares.

14 Section 250. The sum of \$9,108,400, or so much thereof as
15 may be necessary, is appropriated from the Road Fund to the
16 Department of Transportation for making a grant to the Regional
17 Transportation Authority for the funding of the Americans with
18 Disabilities Act of 1990 (ADA) paratransit services and for
19 other costs and services.
