A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. "Operational expenses" defined. For the
6 purposes of this Act, the term "operational expenses"
7 includes the following items:

- 8 (a) Personal Services;
- 9 (b) State contributions to Social Security
- 10 (c) Group Insurances;
- 11 (d) Contractual Services
- 12 (e) Travel;
- 13 (f) Commodities;
- 14 (g) Printing;
- 15 (h) Equipment;
- 16 (i) Electronic data processing;
- 17 (j) Telecommunications services;
- 18 (k) Operation of automotive equipment;
- 19 (l) Refunds;
- 20 (m) Employee retirement contributions paid by the employer;
- 21 (n) Permanent improvements;
- 22 (o) Deposits to other funds.

1 Section 5. In addition to other amounts appropriated,
 2 the amount of \$2,100,000, or so much thereof as may be
 3 necessary, is appropriated from the General Revenue Fund to
 4 the Illinois Emergency Management Agency for operational
 5 expenses, awards, grants, administrative expenses, including
 6 refunds, and permanent improvements for the fiscal year
 7 ending June 30, 2016.

8 Section 10. The following named amounts, or so much
 9 thereof as may be necessary, are appropriated to the Illinois
 10 Emergency Management Agency for the objects and purposes
 11 hereinafter named:

8 Section 15. The sum of \$100,000, or so much thereof as
 9 may be necessary, is appropriated from the Radiation
 10 Protection Fund to the Illinois Emergency Management Agency
 11 for the ordinary and contingent expenses incurred by the
 12 Illinois Emergency Management Agency.

13 Section 20. The amount of \$23,160,000, or so much
 14 thereof as may be necessary, is appropriated from the
 15 Homeland Security Emergency Preparedness Fund to the Illinois
 16 Emergency Management Agency for current and prior year
 17 expenses related to the federally funded Emergency
 18 Preparedness Grant Program.

19 Section 25. The sum of \$50,000, or so much thereof as
 20 may be necessary, is appropriated from the Nuclear Safety
 21 Emergency Preparedness Fund to the Illinois Emergency
 22 Management Agency for the ordinary and contingent expenses

1 incurred by the Illinois Emergency Management Agency.

2 Section 30. The sum of \$12,000,000, or so much thereof
3 as may be necessary, is appropriated from the Disaster
4 Response and Recovery Fund to the Illinois Emergency
5 Management Agency for all current and prior year expenses
6 associated with disaster response and recovery.

7 Section 35. The following named amounts, or so much
8 thereof as may be necessary, are appropriated to the Illinois
9 Emergency Management Agency for the objects and purposes
10 hereinafter named:

22 Section 60. The sum of \$750,000, or so much thereof as
 23 may be necessary, is appropriated from the Radiation
 24 Protection Fund to the Illinois Emergency Management Agency

1 for licensing facilities where radioactive uranium and
2 thorium mill tailings are generated or located, and related
3 costs for regulating the decontamination and decommissioning
4 of such facilities and for identification, decontamination
5 and environmental monitoring of unlicensed properties
6 contaminated with such radioactive mill tailings.

7 Section 65. The sum of \$20,000, or so much thereof as
8 may be necessary, is appropriated from the Radiation
9 Protection Fund to the Illinois Emergency Management Agency
10 for the purpose of funding costs related to environmental
11 cleanup of the Ottawa Radiation Areas Superfund Project under
12 cooperative agreements with the Federal Government.

13 Section 70. The sum of \$100,000, or so much thereof as
14 may be necessary, is appropriated from the Radiation
15 Protection Fund to the Illinois Emergency Management Agency
16 for recovery and remediation of radioactive materials and
17 contaminated facilities or properties when such expenses
18 cannot be paid by a responsible person or an available
19 surety.

20 Section 75. The sum of \$65,000, or so much thereof as
21 may be necessary, is appropriated from the Radiation
22 Protection Fund to the Illinois Emergency Management Agency

1 for local responder training, demonstrations, research,
2 studies and investigations under funding agreements with the
3 Federal Government.

4 Section 80. The sum of \$57,000, or so much thereof as
5 may be necessary, is appropriated from the Nuclear Safety
6 Emergency Preparedness Fund to the Illinois Emergency
7 Management Agency for related training and travel expenses
8 and to reimburse the Illinois State Police and the Illinois
9 Commerce Commission for costs incurred for activities related
10 to inspecting and escorting shipments of spent nuclear fuel,
11 high-level radioactive waste, and transuranic waste in
12 Illinois as provided under the rules of the Agency.

13 Section 85. The sum of \$271,200, or so much thereof as
14 may be necessary, is appropriated from the Sheffield Agreed
15 Order Fund to the Illinois Emergency Management Agency for
16 the care, maintenance, monitoring, testing, remediation and
17 insurance of the low-level radioactive waste disposal site
18 near Sheffield, Illinois.

19 Section 90. The sum of \$990,000, or so much thereof as
20 may be necessary, is appropriated from the Low-Level
21 Radioactive Waste Facility Development and Operation Fund to
22 the Illinois Emergency Management Agency for use in

1 accordance with Section 14(a) of the Illinois Low-Level
2 Radioactive Waste Management Act for costs related to
3 establishing a low-level radioactive waste disposal facility.

4 Section 95. The sum of \$240,000, or so much thereof as
5 may be necessary, is appropriated from the Nuclear Safety
6 Emergency Preparedness Fund to the Illinois Emergency
7 Management Agency for ordinary and contingent expenses of the
8 Illinois Emergency Management Agency to include support of a
9 centralized administrative processing center.

10 Section 99. Effective date. This Act takes effect July 1,
11 2015.
