Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 ARTICLE 1 Section 5. 19	Section 15. The sum of \$34,450,000, or so much thereof as								
20	may be necessary, is appropriated to the Department of Human								
21	Services from the Health and Human Services Medicaid Trust								
22	Fund for awards and grants to developmental disabilities

13	Section 10. The sum of \$65,000,000, or so much thereof as							
14	may be necessary, is appropriated from the Illinois Affordable							
15	Housing Trust Fund to the Department of Revenue for grants,							
16	(down payment assistance, rental subsidies, security deposit							
17	subsidies, technical assistance, outreach, building an							
18	organization's capacity to develop affordable housing projects							
19	and other related purposes), mortgages, loans, or for the							
20	purpose of securing bonds pursuant to the Illinois Affordable							
21	Housing Act, administered by the Illinois Housing Development							
22	Authority.							

- 1 Section 15. The sum of \$3,000,000, or so much thereof as
- 2 may be necessary, is appropriated from the Illinois
- 3 Affordable Housing Trust Fund to the Department of Revenue
- 4 for grants to other state agencies for rental assistance,
- 5 supportive living and adaptive housing.
- 6 Section 20. The sum of \$25,000,000, new appropriation,
- 7 is appropriated and the sum of \$15,000,000, or so much
- 8 thereof as may be necessary and as remains unexpended at the
- 9 close of business on June 30, 2015, from appropriations and
- 10 reappropriations heretofore made in Article 35, Section 30 of
- 11 Public Act 98-0679 is reappropriated from the Federal HOME
- 12 Investment Trust Fund to the Department of Revenue for the
- 13 Illinois HOME Investment Partnerships Program administered by
- 14 the Illinois Housing Development Authority.
- 15 Section 25. The sum of \$8,500,000, or so much thereof as
- 16 may be necessary, is appropriated from the Foreclosure
- 17 Prevention Program Fund to the Department of Revenue for
- administration by the Illinois Housing Development Authority,
- 19 for grants and administrative expenses pursuant to the
- 20 Foreclosure Prevention Program.
- Section 30. The sum of \$11,000,000, or so much thereof as

1	may	be	necessary,	is	appropriated	from	the	Foreclosure

10 Housing Development Authority, for grants and administrative

11 expenses pursuant to the Abandoned Residential Property

Municipality Relief Program.

14 Section 40. The sum of \$25,000,000, new appropriation, is

appropriated and the sum of \$50,000,000, or so much thereof

as may be necessary and as remains unexpended at the close of

business on June 30, 2015, from appropriations heretofore

18 made in Article 35, Section 5 of Public Act 98-0064 is

reappropriated from the Rental Housing Support Program Fund

to the Department of Revenue for current and prior year costs

of the Rental Housing Support Program administered by the
