Makes appropriations for the ordinary and contingent expenses of the Illinois Community College Board for the fiscal year beginning July 1, 2022, as follows:

A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much thereof
6 as may be necessary, respectively, for the objects and purposes
7 hereinafter named, are appropriated from the General Revenue
8 Fund to the Illinois Community College Board for ordinary and
9 contingent expenses:

10	For Personal Services	1,420,000
11	For State Paid Retirement	100
12	For State Contributions to Social	
13	Security, for Medicare	22,000
14	For Contractual Services	386,300
15	For Travel	36,400
16	For Commodities	4,600
17	For Printing	2,100

1 Section 10. The sum of \$1,148,000, or so much thereof as
2 may be necessary, is appropriated from the General Revenue Fund
3 to Illinois Community College Board for costs associated with
4 administering high school equivalency tests.

5 Section 15. The sum of \$3,000,000, or so much thereof as
6 may be necessary, is appropriated from the General Revenue Fund
7 to the Illinois Community College Board for grants to the
8 alternative schools network and other providers.

9 Section 20. The sum of \$150,000 or so much thereof as may
10 be necessary, is appropriated from the General Revenue Fund to
11 the Illinois Community College Board for support of the P-20
12 Council.

13 Section 25. The sum of \$60,200, or so much thereof as may
14 be necessary, is appropriated from the General Revenue Fund to
15 the Illinois Community College Board for awarding scholarships
16 to qualifying graduates of the Lincoln's Challenge Program.

17 Section 30. The sum of \$13,928,700, or so much thereof as
18 may be necessary, is appropriated from the General Revenue Fund
19 to the Illinois Community College Board for the City Colleges
20 of Chicago for educational-related expenses.

1 Section 35. The following named amounts, or so much thereof
 2 as may be necessary, respectively, are appropriated from the
 3 General Revenue Fund to the Illinois Community College Board
 4 for distribution to qualifying public community colleges for
 5 the purposes specified:

6	Small College Grants	548,400
7	Performance Funding Grants	<u>359,000</u>
8	Total	\$907,400

9 Section 40. The sum of \$560,300, or so much thereof as may
 10 be necessary, is appropriated from the General Revenue Fund to
 11 the Illinois Community College Board for costs associated with
 12 the development, support or administration of the Illinois
 13 Longitudinal Data System.

14 Section 45. The sum of \$1,457,900, or so much thereof as
 15 may be necessary, is appropriated from the General Revenue Fund
 16 to the Illinois Community College Board for grants to operate
 17 an educational facility in the former community college
 18 district #541 in East St. Louis.

19 Section 50. The sum of \$1,000,000, or so much thereof as
 20 may be necessary, is appropriated from the General Revenue Fund
 21 to the Illinois Community College Board for costs associated

1 with grants for transitional math and English development.

2 Section 55. The sum of \$23,794,400, or so much thereof as
3 may be necessary, is appropriated from the General Revenue Fund
4 to the Illinois Community College Board for all costs
5 associated with the bridge and workforce programs.

6 Section 60. The following named amounts, or so much thereof
7 as may be necessary, are appropriated to the Illinois Community
8 College Board for all costs associated with career and
9 technical education activities:

10	From the General Revenue Fund	18,972,900
11	From the Career and Technical Education Fund	<u>22,000,000</u>

13 Section 65. The following named amounts, or so much of
14 those amounts as may be necessary, for the objects and purposes
15 named, are appropriated to the Illinois Community College Board
16 for adult education and literacy activities:

17	From the General Revenue Fund:	
18	For payment of costs associated	
19	with education and educational-related	
20	services to local eligible providers	
21	for adult education and	
22	literacy	23,783,600

1 For payment of costs associated
 2 with education and educational-related

6 For payment of costs associated with
 7 education and educational-related
 8 services to local eligible providers
 9 and to Support Leadership Activities,
 10 as Defined by U.S.D.O.E.
 11 for adult education and literacy
 12 as provided by the United States
 13 Department of Education26,800,000

14 Section 70. The following amounts, or so much thereof as
 15 may be necessary, respectively, are appropriated to the
 16 Illinois Community College Board for distribution to qualifying
 17 public community colleges for the purposes specified:

18 From the Personal Property Tax Replacement Fund:

19 Base Operating Grants105,570,000

20 From the Education Assistance Fund:

21 Base Operating Grants83,367,200
 22 Equalization Grants74,764,100

23 Total \$158,131,300

1 Section 75. The sum of \$100,000, or so much thereof as may
2 be necessary, is appropriated from the ICCB Research and
3 Technology Fund to the Illinois Community College Board for
4 costs associated with maintaining and updating instructional
5 technology.

6 Section 80. The sum of \$100,000, or so much thereof as may
7 be necessary, is appropriated from the High School Equivalency
8 Testing Fund to the Illinois Community College Board for costs
9 associated with administering high school equivalency tests.

10 Section 85. The sum of \$10,000,000, or so much thereof as
11 may be necessary, is appropriated from the Illinois Community
12 College Board Contracts and Grants Fund to the Illinois
13 Community College Board to be expended under the terms and
14 conditions associated with the moneys being received, including
15 prior year expenditures.

16 Section 90. The sum of \$525,000, or so much thereof as may
17 be necessary, is appropriated from the ICCB Federal Trust Fund
18 to the Illinois Community College Board for the ordinary and
19 contingent expenses of the Board.

20 Section 95. The sum of \$1,600,000, or so much thereof as
21 may be necessary, is appropriated from the ICCB Adult Education

1 Fund to the Illinois Community College Board for operational
2 expenses associated with administration of adult education and
3 literacy activities.

4 Section 100. The sum of \$4,264,400, or so much thereof as
5 may be necessary, is appropriated from the General Revenue Fund
6 to the Illinois Community College Board to reimburse colleges
7 for costs associated with the Illinois Veterans Grant and
8 Illinois National Guard Grant.

9 Section 105. The sum of \$27,000,000, or so much thereof as
10 may be necessary, is appropriated from the Illinois Community
11 College Board Contracts and Grants Fund to the Illinois
12 Community College Board for grants, contracts, and
13 administrative expenses of the Governor's Emergency Education
14 Relief Fund award.

15 Section 110. The sum of \$50,000,000, or so much thereof
16 as may be necessary, is appropriated from the Illinois
17 Community College Board Contracts and Grants Fund to the
18 Illinois Community College Board for grants and administrative
19 costs associated with early childhood programs.

20 Section 115. The sum of \$25,000,000, or so much thereof as
21 may be necessary, is appropriated from the General Revenue Fund

1 to the Illinois Community College Board for the Pipeline for
2 Advancement of the Healthcare (PATH) Workforce Program.

3 Section 120. The sum of \$150,000, or so much thereof as may
4 be necessary, is appropriated from the General Revenue Fund to
5 the Illinois Community College Board for operational expenses
6 associated with the PATH Workforce Program.

7 ARTICLE 2

8 Section 5. The amount of \$10,000,000, or so much thereof
9 as may be necessary and remains unexpended at the close of
10 business on June 30, 2022, from an appropriation heretofore
11 made for such purpose in Article 127, Section 195 of Public Act
12 102-0017, as amended, is reappropriated from the State
13 Coronavirus Urgent Remediation Emergency Fund to the Illinois
14 Community College Board for costs associated with implementing
15 college bridge programs for purposes permitted by Section 9901
16 of the American Rescue Plan Act of 2021 and related federal
17 guidance.

18 Section 999. Effective Date. This Act takes effect July
19 1, 2022.
