1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much thereof  
6 as may be necessary, respectively, for the objects and purposes  
7 hereinafter named, are appropriated from the Insurance Producer  
8 Administration Fund to the Department of Insurance:

3 Section 10. The sum of \$6,000,000, or so much thereof as  
 4 may be necessary, is appropriated from the Insurance Producer  
 5 Administration Fund to the Department of Insurance for costs  
 6 and expenses related to or in support of Get Covered Illinois.

7 Section 15. The sum of \$5,000,000, or so much thereof as  
 8 may be necessary, is appropriated from the Insurance Producer  
 9 Administration Fund to the Department of Insurance for costs  
 10 and expenses related to or in support of the agency's  
 11 operations.

12 Section 20. The following named amounts, or so much thereof  
 13 as may be necessary, respectively, for the objects and purposes  
 14 hereinafter named, are appropriated from the Insurance  
 15 Financial Regulation Fund to the Department of Insurance:

10 Section 25. The sum of \$5,425,000, or so much thereof as  
 11 may be necessary, is appropriated from the Insurance Financial  
 12 Regulation Fund to the Department of Insurance for costs and  
 13 expenses related to or in support of the agency's operations.

14 Section 30. The sum of \$6,000,000, or so much thereof as  
 15 may be necessary, is appropriated from the Insurance Financial  
 16 Regulation Fund to the Department of Insurance for costs  
 17 associated with the establishment, administration and  
 18 operations of the Workers' Compensation Fraud Unit Information  
 19 Technology System.

20 Section 35. The sum of \$100,000, or so much thereof as may  
 21 be necessary, is appropriated from the George Bailey Memorial  
 22 Fund to the Department of Insurance for grants and expenses

1 related to or in support of the George Bailey Memorial Program.

2 Section 40. The following named amounts, or so much thereof  
3 as may be necessary, respectively, for the objects and purposes  
4 hereinafter named, are appropriated from the Public Pension  
5 Regulation Fund to the Department of Insurance:

19 Section 45. The sum of \$2,600,000, or so much thereof as  
20 may be necessary, is appropriated from the Public Pension  
21 Regulation Fund to the Department of Insurance for costs and  
22 expenses related to or in support of the agency's operations.

1           Section 50. The sum of \$3,200,000, or so much thereof as  
2           may be necessary, is appropriated from the Insurance Producer  
3           Administration Fund to the Department of Insurance for costs  
4           associated with the administration and operations of the  
5           Insurance Fraud Division of the Illinois Workers' Compensation  
6           Commission's Anti-Fraud Program.

7           Section 55. The sum of \$2,000,000, or so much thereof as  
8           may be necessary, is appropriated from the Parity Advancement  
9           Fund to the Department of Insurance for costs and expenses  
10          related to or in support of parity compliance advocacy,  
11          consumer education, and any other initiatives that support  
12          parity implementation and enforcement on behalf of consumers.

13          Section 60. The sum of \$17,800,000, or so much thereof as  
14          may be necessary, is appropriated from the Illinois Health  
15          Benefits Exchange Fund to the Department of Insurance for costs  
16          associated with implementation of a healthcare feasibility  
17          study recommendation.

18          Section 65. The sum of \$1,200,000, or so much thereof as  
19          may be necessary, is appropriated from the Insurance Producer  
20          Administration Fund to the Department of Insurance for ordinary  
21          and contingent expenses related to or in support of the Division  
22          of Healthcare Access.

1           Section 99. Effective date. This Act takes effect July 1,  
2    2024.
