A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much thereof  
6 as may be necessary, respectively, are appropriated to the  
7 Illinois State Police for the following purposes:

8 DIVISION OF JUSTICE SERVICES

9 Payable from General Revenue Fund:

10	For New Forensic Lab Expenses .....	0
11	For Payment of Tort Claims .....	50,000
12	For Refunds .....	<u>2,000</u>
13	Total	\$52,000

14 Payable from the State Police Wireless

15 Service Emergency Fund:

16	For costs associated with the

1           Section 10. The sum of \$4,000,000, or so much thereof as  
2           may be necessary, is appropriated from the State Asset  
3           Forfeiture Fund to the Illinois State Police for payment of  
4           their expenditures as outlined in the Drug Asset Forfeiture  
5           Procedure Act, the Cannabis Control Act, and the Illinois  
6           Controlled Substances Act.

7           Section 15. The sum of \$2,500,000, or so much thereof as  
8           may be necessary, is appropriated from the Federal Asset  
9           Forfeiture Fund to the Illinois State Police for payment of  
10          their expenditures in accordance with the Federal Equitable  
11          Sharing Guidelines.

12          Section 20. The sum of \$2,000,000, or so much thereof as  
13          may be necessary, is appropriated to the Illinois State Police,  
14          Division of Justice Services, from the Money Laundering Asset  
15          Recovery Fund for the ordinary and contingent expenses incurred  
16          by the Illinois State Police.

17          Section 25. The sum of \$1,000,000, or so much thereof as  
18          may be necessary, is appropriated from the LEADS Maintenance  
19          Fund to the Illinois State Police, Division of Justice  
20          Services, for expenses related to the LEADS System.

21          Section 30. The following named amounts, or so much thereof

1 as may be necessary, respectively, are appropriated to the  
2 Illinois State Police for the following purposes:

23 Section 35. The following amount, or so much thereof as  
 24 may be necessary for objects and purposes hereinafter named,

1 is appropriated from the Drug Traffic Prevention Fund to the  
 2 Illinois State Police, Division of Operations, pursuant to the  
 3 provisions of the Intergovernmental Drug Laws Enforcement Act  
 4 for Grants to Metropolitan Enforcement Groups.

5 For Grants to Metropolitan Enforcement Groups:

6 Payable from the Drug Traffic  
 7 Prevention Fund .....500,000

8 Section 40. The sum of \$18,000,000, or so much thereof as  
 9 may be necessary, is appropriated from the State Police  
 10 Whistleblower Reward and Protection Fund to the Illinois State  
 11 Police for payment of their expenditures for state law  
 12 enforcement purposes.

13 Section 45. The sum of \$45,000,000, or so much thereof as  
 14 may be necessary, is appropriated from the State Police  
 15 Operations Assistance Fund to the Illinois State Police for the  
 16 ordinary and contingent expenses incurred by the Illinois State  
 17 Police.

18 Section 50. The sum of \$13,000,000, or so much thereof as  
 19 may be necessary, is appropriated from the State Police Law  
 20 Enforcement Administration Fund to the Illinois State Police,  
 21 Division of Operations, for all costs associated with a cadet  
 22 program for the Illinois State Police.

1           Section 55. The sum of \$2,000,000, or so much thereof as  
 2           may be necessary, is appropriated from the Scott's Law Fund to  
 3           the Illinois State Police for the ordinary and contingent  
 4           expenses incurred by the Illinois State Police.

5           Section 60. The sum of \$40,000,000, or so much thereof as  
 6           may be necessary, is appropriated from the Illinois State  
 7           Police Federal Projects Fund to the Illinois State Police for  
 8           costs related to federal awards and grants, including prior  
 9           years' costs.

10          Section 65. The sum of \$6,000,000, or so much thereof as  
 11          may be necessary, is appropriated from the State Police  
 12          Training and Academy Fund to the Illinois State Police for  
 13          expenses related to State Police Training.

14          Section 70. The following named amounts, or so much thereof  
 15          as may be necessary, respectively, are appropriated to the  
 16          Illinois State Police for the following purposes:

16 Section 75. The sum of \$2,250,000, or so much thereof as  
 17 may be necessary, is appropriated to the Illinois State Police,  
 18 Division of Forensic Services and Identification, from the  
 19 Mental Health Reporting Fund for expenses as outlined in the  
 20 Firearm Concealed Carry Act and the Firearm Owners  
 21 Identification Card Act.

22 Section 80. The sum of \$29,500,000, or so much thereof as  
 23 may be necessary, is appropriated to the Illinois State Police



1 from the State Police Firearm Services Fund for expenses as  
2 outlined in the Firearm Concealed Carry Act and the Firearm  
3 Owners Identification Card Act.

4 Section 85. The sum of \$230,000,000, or so much thereof  
5 as may be necessary, is appropriated from the Statewide 9-1-1  
6 Fund to the Illinois State Police, Division of Justice  
7 Services, for costs pursuant to the Emergency Telephone System  
8 Act.

9 Section 90. The sum of \$2,000,000, or so much thereof as  
10 may be necessary, is appropriated from the State Police  
11 Revocation Enforcement Fund to the Illinois State Police, for  
12 grants to law enforcement agency task forces for participating  
13 in programs to help reduce crime.

14 Section 95. The sum of \$1,300,000, or so much thereof as  
15 may be necessary, is appropriated from the General Revenue Fund  
16 to the Illinois State Police, for the ordinary and contingent  
17 expenses of the Safe2Help Program.

18 Section 99. Effective date. This Act takes effect July 1,  
19 2024.
