AN ACT concerning appropriations.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

ARTICLE 5

5 Section 5. The sum of \$1,201,400, or so much thereof as may 6 be necessary, is appropriated from the General Revenue Fund to 7 the Commission on Government Forecasting and Accountability to 8 meet its operational expenses for the fiscal year ending June 9 30, 2019.

10 Section 10. The sum of \$1,500,000, or so much thereof as 11 may be necessary, is appropriated from the General Revenue Fund 12 to the Commission on Government Forecasting and Accountability 13 for the purpose of making pension pick up contributions to the 14 State Employees' Retirement System of Illinois for affected 15 legislative staff employees.

Section 15. The sum of \$263,200, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Legislative Audit Commission to meet its operational expenses for the fiscal year ending June 30, 2019. HB5840 -2- HDS100 00120 TWH 10122 b Section 20. The sum of \$2,950,700, or so much thereof as may be necessary, is appropriated from the General Revenue Fund

3 to the Legislative Research Unit to meet its operational 4 expenses for the fiscal year ending June 30, 2019.

5 Section 25. The sum of \$1,140,700, or so much thereof as 6 may be necessary, is appropriated from the General Revenue Fund 7 to the Joint Committee on Administrative Rules to meet its 8 operational expenses for the fiscal year ending June 30, 2019.

9 Section 30. The sum of \$5,166,700, or so much thereof as 10 may be necessary, is appropriated from the General Revenue Fund 11 to the Legislative Information System to meet its operational 12 expenses for the fiscal year ending June 30, 2019.

13 Section 35. The following sum, or so much of that amount 14 as may be necessary, is appropriated from the General Assembly 15 Computer Equipment Revolving Fund to the Legislative 16 Information System:

4 Section 45. The sum of \$2,581,400, or so much thereof as 5 may be necessary, is appropriated from the General Revenue Fund 6 to the Legislative Reference Bureau to meet its operational 7 expenses for the fiscal year ending June 30, 2019.

8 Section 50. The sum of \$1,669,500, or so much thereof as 9 may be necessary, is appropriated from the General Revenue Fund 10 to the Architect of the Capitol to meet its operational expenses 11 for the fiscal year ending June 30, 2019.

ARTICLE 10

13 Section 5. The sum of \$312,500, or so much thereof as may 14 be necessary, is appropriated from the General Revenue Fund to 15 the Legislative Ethics Commission to meet the ordinary and 16 contingent expenses of the Commission and the Office of 17 Legislative Inspector General.

18 Section 99. Effective date. This Act takes effect July 1,19 2018.
