

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named amounts, or so much
6 thereof as may be necessary, respectively, for the objects
7 and purposes hereinafter named, are appropriated from the
8 Illinois Workers' Compensation Commission Operations Fund to
9 the Illinois Workers' Compensation Commission:

5 Section 10. The amount of \$75,000, or so much thereof as
 6 may be necessary, is appropriated from the Illinois Workers'
 7 Compensation Commission Operations Fund to the Illinois
 8 Workers' Compensation Commission for the implementation and
 9 operation of an accident reporting system.

10 Section 15. The following named amounts, or so much
 11 thereof as may be necessary, respectively, for the objects
 12 and purposes hereinafter named, are appropriated from the
 13 Illinois Workers' Compensation Commission Operations Fund to
 14 the Illinois Workers' Compensation Commission:

5 Section 20. The amount of \$2,013,400, or so much thereof
6 as may be necessary, is appropriated from the Illinois
7 Workers' Compensation Commission Operations Fund to Illinois
8 Workers' Compensation Commission for costs associated with
9 the establishment, administration and operations of the
10 Insurance Compliance Division of the workers' compensation
11 anti-fraud program administered by Illinois Workers'
12 Compensation Commission.

13 Section 25. The amount of \$90,000, or so much thereof as
14 may be necessary, is appropriated from the Illinois Workers'
15 Compensation Commission Operations Fund to Illinois Workers'
16 Compensation Commission for costs associated with the
17 establishment of the Medical Fee Schedule and other
18 provisions of the Workers' Compensation Act.

19 Section 99. Effective date. This Act takes effect July 1,
20 2014.
