9 Sec. 5. The sum of \$168,900 ~~187,700~~, or so much thereof
10 as may be necessary, is appropriated from the Guardianship
11 and Advocacy Fund to the Guardianship and Advocacy Commission
12 for services pursuant to Section 5 of the Guardianship and
13 Advocacy Act.

14 Section 99. Effective date. This Act takes effect upon
