12 Section 30. The sum of \$50,000, or so much thereof as 13 may be necessary, is appropriated from the General Revenue 14 Fund to the Department of Veterans' Affairs for costs 15 associated with Veterans' Conservation Corps.

16 Section 35. The sum of \$250,000, or so much thereof as 17 may be necessary, is appropriated from the Illinois Military 18 Family Relief Fund to the Department of Veterans' Affairs for 19 the payment of benefits authorized under the Survivor's 20 Compensation Act.

Section 99. Effective date. This Act takes effect July 1,2009.
