1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named amounts, or so much  
6 thereof as may be necessary, respectively, for the objects  
7 and purposes hereinafter named, are appropriated to meet the  
8 ordinary and contingent expenses for the Department of the  
9 Lottery, including operating expenses related to Multi-State  
10 Lottery games pursuant to the Illinois Lottery Law:

17 Section 5. The sum of \$535,700, or so much thereof as  
 18 may be necessary, is appropriated from the State Lottery Fund  
 19 to the Department of the Lottery for costs and expenses  
 20 related to or in support of a Government Services shared  
 21 services center.

22 Section 99. Effective date. This Act takes effect July 1,  
 23 2013.
