2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named amounts, or so much thereof

7 hereinafter named, are appropriated to meet the ordinary and

10 Section 99. Effective Date. This Act takes effect July 1,
11 2018. Notwithstanding anything in this Act to the contrary,
12 appropriations authorized in this Act shall be used for all
13 costs incurred prior to July 1, 2019.
