1 AN ACT concerning appropriations.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 ARTICLE 1 Section 5. 22	Section 10. The sum of \$11,500,000, or so much thereof
23	as may be necessary, is appropriated from the Federal Support
24	Agreement Revolving Fund to the Department of Military

- 1 Affairs Facilities Division for expenses related to Army
- 2 National Guard Facilities operations and maintenance as
- 3 provided for in the Cooperative Funding Agreements, including
- 4 costs in prior years.
- 5 Section 15. The sum of \$7,400, or so much thereof as may
- 6 be necessary, is appropriated from the General Revenue Fund
- 7 to the Department of Military Affairs Office of the Adjutant
- 8 General Division for expenses related to the care and
- 9 preservation of historic artifacts.
- Section 20. The sum of \$3,000,000, or so much thereof as
- 11 may be necessary, is appropriated from the Military Affairs
- 12 Trust Fund to the Department of Military Affairs Office of
- 13 the Adjutant General Division to support youth and other
- 14 programs, provided such amounts shall not exceed funds to be
- made available from public or private sources.
- Section 25. The sum of \$5,000,000, or so much thereof as
- may be necessary, is appropriated from the Illinois Military
- 18 Family Relief Fund to the Department of Military Affairs
- 19 Office of the Adjutant General Division for the issuance of
- 20 grants to persons or families of persons who are members of
- 21 the Illinois National Guard or Illinois residents who are
- 22 members of the armed forces of the United States and who have

- 1 been called to active duty as a result of the September 11,
- 2 2001 terrorist attacks, including costs in prior years.
- 3 Section 30. The sum of \$1,247,400, or so much thereof as
- 4 may be necessary, is appropriated from the Federal Support
- 5 Agreement Revolving Fund to the Department of Military
- 6 Affairs Facilities Division for expenses for operations and
- 7 maintenance according to Joint-Use Agreement, including costs
- 8 in prior years.
- 9 Section 99. Effective date. This Act takes effect July 1,
- 10 2010.
