HOUSE MOTION

MR. SPEAKER:

I move that House Bill 1001(ss) be amended to read as follows:

| 1 | Page 1, between the enacting clause and line 1, begin a new |

| 6 | 2022. Notwithstanding any other law, if, after the calculation required |
| 7 | by section 1(d) of this chapter, the budget agency certifies that the |
| 8 | state's combined reserve balance as calculated in section 1(d) of this |
| 9 | chapter exceeds two billion five hundred million dollars |
| 10 | (\$2,500,000,000), the budget agency, after budget committee review, |
| 11 | shall transfer the amount of combined state reserves that exceed two |
| 12 | billion five hundred million dollars (\$2,500,000,000) to the pre-1996 |
| 13 | account (as defined in IC 5-10.2-1-5.5) for the purposes of the pre-1996 |
| 14 | account. However, the amount transferred under this section may not |
| 15 | exceed two billion five hundred million dollars (\$2,500,000,000). one |
| 16 | billion dollars (\$1,000,000,000).". |
| 17 | Page 30, after line 42, begin a new paragraph and insert: |
| 18 | "SECTION 15. [EFFECTIVE UPON PASSAGE] (a) Two billion |
| 19 | dollars (\$2,000,000,000) is appropriated from the state general |
| 20 | fund to the budget agency to supplement the amounts appropriated |

1 to the capital reserve account in P.L.165-2021 (HEA 1001-2021). 2 The money appropriated under this subsection may be used for the 3 following purposes: 4 (1) Funding enhanced public health programs. 5 (2) For any other purpose. 6 (b) This subsection applies beginning on the date of the 7 enactment of this SECTION. The budget agency shall submit to the 8 general assembly a proposal for the uses of the funds in the capital 9 reserve account in P.L.165-2021 (HEA 1001-2021) for the general 10 assembly's action or approval. The budget agency may not expend 11 or otherwise encumber or pledge funds in the capital reserve 12 account, or the supplemental amount appropriated to the account 13 in subsection (a), until a proposal under this subsection has been 14 submitted to and approved by the general assembly. This 15 subsection applies only to those funds in the capital reserve account 16 on the date of the enactment of this SECTION and the 17 supplemental amount appropriated to the account in subsection 18 (a). This subsection does not apply to funds that have been 19 expended from the account or are otherwise encumbered or 20 pledged before the date of the enactment of this SECTION. 21 (c) The proposal required to be submitted by the budget agency 22 under subsection (b) must be submitted to the general assembly on 23 or before December 15, 2022. 24 (d) This SECTION expires June 30, 2023.".
