MADAM PRESIDENT:

I move that Engrossed House Bill 1183 be amended to read as follows:

- 1 Page 2, between lines 35 and 36, begin a new paragraph and insert:
- 2 **"Sec. 2. This chapter does not apply to an acquisition or lease of**
- 3 **agricultural land in a county that adopts an ordinance under**
- 4 **IC 32-22-3-4.5(c)."**
- 5 Page 2, line 36, delete "2." and insert "3."
- 6 Page 2, line 38, delete "3." and insert "4."
- 7 Page 2, line 40, delete "4." and insert "5."
- 8 Page 2, line 42, delete "5." and insert "6."
- 9 Page 3, line 5, delete "6." and insert "7."
- 10 Page 3, line 9, delete "5" and insert "6".
- 11 Page 4, line 29, after "Indiana." insert **"This subdivision does not**
- 12 **apply to an acquisition of agricultural land in a county that adopts**
- 13 **an ordinance under subsection (c)."**
- 14 Page 4, line 32, delete "renewal of a lease for agricultural land that
- 15 is in" and insert **"following:**
- 16 **(A) The renewal of a lease for agricultural land that is in**
- 17 **place prior to July 1, 2024, if the acreage and description**
- 18 **of the agricultural land subject to the lease does not**
- 19 **change.**
- 20 **(B) A lease of agricultural land in a county that adopts an**
- 21 **ordinance under subsection (c)."**

- 23 Page 4, between lines 40 and 41, begin a new paragraph and insert:
- 24 **"(c) A county executive may adopt an ordinance that waives the**
- 25 **application of:**
- 26 **(1) subsection (b)(1);**
- 27 **(2) subsection (b)(2); or**

1 **(3) subsection (b)(1) and subsection (b)(2);**
2 **to the acquisition or lease of agricultural land that was zoned by**
3 **the county for industrial use at least five (5) years before the date**
4 **of adoption of the ordinance by the county executive."**
5 Page 4, line 41, delete "(c)" and insert "(d)".
6 Page 5, line 2, delete "(d)" and insert "(e)".
7 Page 5, line 5, delete "(e)" and insert "(f)".
8 Page 6, between lines 33 and 34, begin a new paragraph and insert:
9 **"Sec. 4. This chapter does not apply to the acquisition or lease**
10 **of agricultural land in a county that adopts an ordinance under**
11 **section 6 of this chapter."**
12 Page 6, line 34, delete "4." and insert "5".
13 Page 7, line 13, delete "5 and 6" and insert "**7 and 8**".
14 Page 7, between lines 16 and 17, begin a new paragraph and insert:
15 **"Sec. 6. A county executive may adopt an ordinance that waives**
16 **the application of:**
17 **(1) section 5(a)(1) of this chapter;**
18 **(2) section 5(a)(2) of this chapter;**
19 **(3) section 5(a)(3) of this chapter;**
20 **(4) section 5(a)(4) of this chapter; or**
21 **(5) any combination of section 5(a)(1), 5(a)(2), 5(a)(3), or**
22 **5(a)(4) of this chapter;**
23 **to the acquisition or lease of agricultural land that was zoned by**
24 **the county for industrial use at least five (5) years before the date**
25 **of adoption of the ordinance by the county executive."**
