I move that House Bill 1365 be amended to read as follows:

1 Page 66, between lines 38 and 39, begin a new paragraph and insert: 2 "SECTION 86. IC 3-12-1-1, AS AMENDED BY P.L.64-2014, 3 SECTION 68, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE 4 JULY 1, 2021]: Sec. 1. Subject to sections 5, 6, 7, 8, 9, and 9.5 and 13 5 of this chapter, the primary factor to be considered in determining a 6 voter's choice on a ballot is the intent of the voter. If the voter's intent 7 can be determined on the ballot or on part of the ballot, the vote shall 8 be counted for the affected candidate or candidates or on the public 9 question. However, if it is impossible to determine a voter's choice of 10 candidates on a part of a ballot or vote on a public question, then the 11 voter's vote concerning those candidates or public questions may not 12 be counted.".

Page 68, between lines 3 and 4, begin a new paragraph and insert: "SECTION 88. IC 3-12-1-12 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2021]: Sec. 12. (a) This section applies to votes cast by any method.

(b) Except as provided in section 13 of this chapter, A ballot that has been marked and cast by a voter in compliance with this title but may otherwise not be counted solely as the result of the act or failure to act of an election officer may nevertheless be counted in a proceeding under IC 3-12-6, IC 3-12-8, or IC 3-12-11 unless evidence

1	of fraud, tampering, or misconduct affecting the integrity of the ballot
2	is presented by a party to the proceeding.
3	(c) The act or failure to act by an election officer is not by itself
4	evidence of fraud, tampering, or misconduct affecting the integrity of
5	the ballot.
6	SECTION 89. IC 3-12-1-13 IS REPEALED [EFFECTIVE JULY 1,
7	2021]. Sec. 13. (a) This section applies only to absentee ballots.
8	(b) The whole ballot may not be counted unless the ballot is
9	endorsed with the initials of:
10	(1) the two (2) members of the absentee voter board under
11	IC 3-11-4-19, IC 3-11-10-25, IC 3-11-10-26, IC 3-11-10-26.3, or
12	IC 3-11-18.1-11; or
13	(2) the two (2) appointed members of the county election board
14	(or their designated representatives) under IC 3-11-4-19.".
15	Renumber all SECTIONS consecutively.
